ORDINANCE NO. 14-7

AN ORDINANCE AMENDING AND RESTATING THE TOWN OF BRIDGEVILLE OPERATING AND CAPITAL BUDGETS FOR FISCAL YEAR ENDING JUNE 30, 2015

WHEREAS, the Commissioners of Bridgeville adopted a FY 2015 budget and established property tax rates and water and sewer service charges on May 28, 2014; and

WHEREAS, the Commissioners of Bridgeville have determined that it is appropriate to amend and restate the FY 2015 budget in order to clarify revenues and expenditures and to re-establish rates for property taxes, water and wastewater service charges;

NOW, THEREFORE, BE IT **ORDAINED** BY THE COMMISSIONERS OF BRIDGEVILLE:

Section 1. The statement of anticipated revenues and other funding sources for the FY 2015 is established as follows:

The Commissioners have determined and fixed a rate of taxation for real estate at \$2.40 per \$100 of assessed value, effective July 1, 2014.

*No money is set aside for reserves except for all transfer tax receipts received in excess of budgeted amount (\$92,248).

Section 2. The statement of anticipated expenditures for the FY 2015 is established as follows:

The Commissioners have determined the rate for water service shall be \$2.79 per thousand for the first five thousand gallons used (0-5000) per month, \$3.35 per thousand gallons for the second five thousand gallons used (5001-10,000), and \$3.75 per thousand gallons over ten thousand gallons used (10,000+).

The Commissioners have determined the rate for the monthly water meter fee shall be \$7.50, with the exception that all secondary meters used for irrigation will be charged \$5.50 per month.

The Commissioners have determined the rate for wastewater service shall be a \$24.00 flat rate for the first twenty five hundred gallons used (0-2500) per month, \$7.10 per thousand gallons for the second twenty five hundred gallons used (2501-5000), \$8.50 per thousand gallons for the next five thousand gallons used (5001-10,000), and \$13.00 per thousand gallons over ten thousand gallons used (10,000+).

Section 3. This ordinance shall become effective upon its adoption by a majority of the members elected to the Commissioners of Bridgeville.
