13 Section 1. Amend Chapter 222 “VEHICLES AND TRAFFIC”, Section 207
14 “Schedule XXIV: Designated Streets”, of the Code of the Town of Bridgeville, to
15 include additional accepted streets by adding thereto the underlined text, as follows:
