ORDINANCE 16-3

AN ORDINANCE AMENDING CHAPTER 17, ARTICLE II OF THE BRIDGEVILLE CODE RELATING TO THE DESCRIPTION OF ELECTION VOTING DISTRICTS WITHIN THE BOUNDARIES OF THE TOWN OF BRIDGEVILLE TO ADD 502 SOUTH MAIN STREET TO DISTRICT NO. 5

WHEREAS, the General Assembly of the State of Delaware enacted "AN ACT TO AMEND CHAPTER 237, VOLUME 51, ENTITLED 'AN ACT TO REINCORPORATE THE TOWN OF BRIDGEVILLE' PERMITTING THE COMMISSIONERS OF BRIDGEVILLE BY ORDINANCE, TO ESTABLISH ELECTION DISTRICTS";

WHEREAS, the Commissioners of Bridgeville initially established election districts by the adoption of Ordinance No. A 07-9, adopted December 10, 2007 and by Ordinance No. A 11-6, adopted January 9, 2012; and

WHEREAS, an annexation referendum was held on May 14, 2015, at which the real property of Glenna J. Smith Revocable Trust, identified as 502 S. Main Street, identified on the tax maps of the Sussex County Department of Finance, as T.M. No. 131-10.20-105, was annexed into the boundaries of the Town of Bridgeville; and

WHEREAS, the Commissioners of Bridgeville are desirous of reestablishing the election districts within the Town in accordance with Section 5, of Chapter 237, Volume 51, Laws of Delaware, relating to Elections, in order to place the above mentioned property in an election district.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE COMMISSIONERS OF BRIDGEVILLE:

Section 1. Amend the official 2011 Election District Map of the Town of Bridgeville to include within Election District No. 5 the real property located at 502 S. Main Street, identified on the tax maps of the Sussex County Department of Finance, as T.M. No. 131-10.20-105.

Section 2. Amend Bridgeville Code, Chapter 17, Article II, Election Districts, by deleting its text in its entirety and adding in lieu thereof the following:

§ 17-15. Description of districts.

A. ...

B. The official 2011 Election District Map, as amended by this ordinance, shall be identified by the signature of the President, attested by the Town Secretary, and bearing the Seal of the Town under the following words:

“This is to certify that this is the Official 2011 Election Districts Map referred to in Section 17-15, Chapter 17 of the Bridgeville Code and referred to in Section 1, of Ordinance No. A 11-06 of the Town of Bridgeville, adopted on the January 9, 2012, as amended by Ordinance No. 16-3, adopted on the 8th day of August, 2016.”

Section 3. This Ordinance shall be effective upon its adoption by a majority of all members elected to the Commissioners of Bridgeville.
