

MINUTES FROM THE COMMISSION MEETINGS:

APRIL 10, 2000:

-There were 312 traffic arrests with 71 criminal arrests. One truck stopped

in Town during March.

-There were three septic haulers for a revenue of \$2,520. Now receiving bids for a new pump at the septic receiving station.

-The fire hydrant damaged by a vehicle on Market Street has been repaired.

-Commissioners approved the cost proposal from the Universit of Delaware to complete a Comprehensive Plan for the Town. Cost \$9,940.

-An executive order was decided on pertaining to outside contracting fees. \$35.00/hr Man Hours

\$50.00/hr Vehicle/Equipment

-Commissioners voted to change carriers regarding the Town; s liability insurance from H.M. James & Son to J.A. Montgomery.

It was voted to send Chief Parsons to a Community Policing Seminar in May to be held at the Inn Harbor in Baltimore,

Maryland.

-Mrs. Marge Flynn requested a trash bin be placed on John Street.

MAY 8, 2000:

-There were 346 traffice arrests and one truck stopped during April.

-The 1996 and 1995 police vehicles have had new enigines installed.

-Police department building will be examined for termite infestion.

-Chief Parsons will be attending a week long course in Baltimore on Community Policing.

-The average daily septic flow was .216

milllion gallons per day.

-Three septic haulers for a revenue of

\$2,160.

-Presdient Dalton will meet with Nanticoke Hospital Officials and DNREC concerning an application for hook-up at Dr. SMith's office to the Town sewer.

-The average daily water supplied was

75,000 gallons.

A three year maintenance contract for the water toweris \$13,700.

-Town made arrangements with the Passwaters' family to lease a piece of land for \$1.00. This will enable Jason Deibel to build a playground at the little league field as part of his Eagle Scout Project.

-Team members for the University of Delaware and DelDOT presented a program explaining the Comprehensive Plan for Bridgeville and what the plan would entail. More info will be coming in the next few

months.

-Bridgeville Lioness have been given permision to place a park bench in the park area across from Town Hall.

-Commissioners approved the CPCN (Certificate of Public Convenience and Necessity) license which is from the state allowing the Town to provide water in the surrounding Cost for the Town's engineering firm to prepare the CPCN is \$2,850.

-Commissioners approved to have the engineering firm prepare the Application for Federal Assistance for

a cost of \$2,400.

-Estimates to have the upstairs heat pump replaced will be acquired in the next few weeks.

-Discussion was held on painting the woodwork on all buildings owned by

-It was approved to purchase new letterhead paper for the police department for a cost of \$160.

-Letter received from Daryl Tull requesting the Town to run sewer and water lines to a piece of property he ownes onRt. 404. Approximately \$37,000.

-Resolution #R02200 was received from Sussex County Council pertaining to the Sussex Comprehensive Plan

-President Dalton stated there is potential development that is to take place on land owned by Coulter Passwaters.

-Boot Camp workers cleaned several streets of sand and salt that was spread during the winter storms.

JUNE 12,2000:

-There were 238 traffic arrests and 14 cominal arrests. A total of five trucks were stopped in Town.

-There were two septic haulers for the

month for a revenue of \$1,554.

-The Consumer Confidence Reports are completed and will delieverd the week of June 12, 2000.

-Mr. Daryl Tull asked the Commission if they would take a stand on whether they were going to run sewer and water lines to his land west of Rt.404. Commission voted not to run the lines to that piece of property.

-It has been confirmed that the police department has a termite problem. Will be getting estimates to install a trap door in the front of building to enable the exterminator to evaluate the front part of the building.

-Chief Parsons gave a presentation on the conference he recently attended on Community Policing. Gave several suggestions that could be used in our community.

-Miss Diane Lofland from the New Coverdale Outreach Mission, Inc. explained about the work she is doing with the food bank and soup kitchen.

-Commission approved the installation of a new heat/air system for part of the Town Hall as soon as all the bids are received and a contractor is selected.

-Approval was given to upgrade the property tax program for the Town

Hall computer.

-A special meeting will be held on Monday, June 19,2000 to discuss the budget for 2000/2001 plus some other items.

-It was voted to charge Cannon Cold Storage a fee for each day they were late in submitting their Preliminary Engineering Evaluation.

-Mr. Philip Davis thanked the Commission for their concern with a situation he was experiencing.

FROM THE PRESIDENT'S DESK....



I join the rest of the Commission and our citizens in mourning the loss to the community of Brent Adams. Attending the funeral service you got a feel for how loved he was and how important his life was to so many people. A dedicated father, a trusted friend and a respected business leader, he personified all the attributes of a community leader.

I want you to take notice as you travel around town how good our green spaces look. The Historical Society has done a fantastic job on the park on Delaware Avenue. Every year it looks better and better. It made a lovely setting for the prom ceremonies for our graduating seniors. also at the park at Main and Market Streets as well as the area around Town Hall. We all know and appreciate the dedication of Margaret (Bootsie) Sipple in keeping it loo ing so good. Many days you will see her out there digging, trimming, and planting with the help of Rick Passwaters moving and replacing plants around Town Hall.

We are also pleased that the installation of the handicap ramp for Town Hall has been completed. This not only makes Town Hall handicapped accessible with a parking space right at the bottom of the ramp, it makes it easier for the rest of us in en-

tering from the parking lot.

During the last couple of months we have experienced a number of complaints of people keeping livestock: goats and chickens in town. We also have an ongoing problem with stray dogs and cats. Our town attorney tells us that our Town Code is lacking in properly stating what is acceptable for in town. On Saturday last, a citizen witnessed a car coming through town, stopping quickly, and abandoning a cat on the street.

PRESIDENT'S REPORT cont.

This is one of the areas of the Town Code that the Commission needs to address.

At the last Sussex County Association of Towns (SCAT), one of the other Mayors said that they had appointed a committee to look at their code and remove those ordinances that were outdated, and make sure that the code was current with the times. I am asking for volunteers for people to serve on such a committee to make recommendations to the Commission on what we need to do to up-date our code.

You will remember that two years ago when we looked at doing trash service in town we faced two problems. First, not everyone wanted to have their trash picked up under a contract. Second, we received only one bid due to the fact that the industry had consolidated and there was only one vendor available and they had a price that do not give us a break over the indiviual service we had.

I mentioned at that time that we could wait until the industry changed and try again. Well, it has changed. There is a company from Baltimore that saw the potential for business in this area, and they have approached us with an offer. We cannot take their offer without going to bid on the project but it looks like we now have the opportunity to get a better price. It also appears that we can negotiate a contract that will be voluntary. This means that those who wish not to participate can chose not to. It will require that we guarantee a minimum of customers, but I feel we can meet that number by those who wish to save as much as \$20 a quarter over what they are paying now. We will have more information available soon and will keep you posted.

But,like everything else, I had to learn. So, when we had a Rotating Biological Contactor gearbox fail in my first few weeks, like anybody, I had no

idea what it was. I soon found out they were expensive, and we had eight of 'em! Taking care of that problem educated me. I began a program at Del-Tech, attended the Delaware Rural Water Association Convention in February. Now, you can bet your sweet wastewater I'm gettin' a handle on this 'crap'.

Since munincipal sewage treatment is beyond the daily concern of most of us (til something doesn't work), we all still care about how much our sewer bill is. I invite everyone to take the time to see what you are paying for. Take a tour of the plant some time...just call ahead so we can have someone to show you around. We've got a fine crew at the WWTP with Phil, Doug, and Rick, who can answer any questions you have.

I don't mind calls at home, however, sending correspondence to me in care of the Town Office would get a more prompt response either from me or someone who can answer better than I.

ATTENTION ALL RESIDENTS!

REMINDER: ALL residents who have unpaid water and sewer bill over 60 days old will have water services disconnected without further advance warning notices (no more red tags) being issued. For each disconnect there will be a charge of \$25.00 to have service reconnected. This has been in effect since April 1, 1999.

LOOK INSIDE: your June water/sewer bill will be enclosed with the Town Property Tax Bill. To avoid a penalty on your taxes, please pay before September 30, 2000.

IT'S THAT TIME OF YEAR AGAIN...

The Town Code does have regulations for unregulated grass and weeds.

CHAPTER 90: no owner of land shall permit the unregulated growth of vegetation, including but not limited to weeds, grass, bushes, and shrubs, to be maintained on any property within the corporate limits of Bridgeville.

No weeds, grass, or other ground cover vegetation shall exceed a height of eight (8) inches at any time of the calendar year.

Upon failure of the property owner to comply, the Town Office shall issue a written notice to said owner ordering compliance. If property owner does not remedy the violation with 10 days of notice, the Town shall cause the violation to be corrected, and the cost incurred shall be billed to the property owner. Failure to page said bill could be followed by a court hearing.

Chapter 90 will be enforced by the Commission.

SHORTCUTS WORTH SHARING

- * Need lots of ice for summer party or picnic? Start making ice cubes a few days before the event and store them in the freezer in a brown paper bag until you have a sufficient amount. The cubes will not stick together, and everyone can enjoy ice-cold beverages.
- * To prevent apple pies from getting juicy or soggy on the bottom, crush a few cornflakes and sprinkle over the bottom crust before adding the apples.
- * When celery loses its crispness, place the stalks in a pan of water and slice a raw potato into the pan. Let stand a few hours. Remove the celery, and you'll find it has regained its original crispness.
- * Buy bananas in bulk when prices are low. Peel them and cut into halves or thirds; store in a sealed glass jar in the refrig. The bananas will keep at least 2½ weeks.
- * Have whipped cream ready whenever you need it...whip up the whole pint, scoop cream by large spoonfuls onto a cookie sheet covered w/plastic wrap and freeze. Put frozen dollops into a freezer bag and store in freeer. Remove and thaw as needed.




