

FROM THE PRESIDENT'S DESK....

Things are really poppin' in Bridgeville! Construction at Heritage Shores is well underway.



The Bridgeville Commission is pleased to announce the adoption of its Fiscal 2005 Budget. Again, this budget is the largest in Bridgeville's history and it will continue to grow as Heritage Shores is developed. Growing budgets almost always mean increased taxes and fees, but this is not the case in Bridgeville. Because of our planned growth, the Commission was able to eliminate our

Capitation Tax, a tax by and large paid by residential property owners, and to cut the monthly water meter fee in half. These cuts will result in an annual savings to the average family in Bridgeville of \$72. When you add that to the rebate in County Taxes proposed by the Sussex County Council, the residents of Bridgeville will save over \$100 in taxes and fees this year. Thank County Councilman Finley Jones the next time you see him. Planned growth, as we have here in Bridgeville, and as practiced by the Sussex County Council, has resulted in tax savings for all of us.

The FY-05 Budget also includes a number of other features. A list of the highlights of this budget can be found elsewhere in the Journal. Let me point out some of the things that have been or will be done in Fiscal 2005. We have repaid the \$200,000 operational loan executed by a previous Commission to pay bills. We will be adding a sixth policeman. With the addition of the present police trainee to our force in June, we will have two police officers available on some shifts. Two new police vehicles are being purchased. A number of capital improvements to the Town Hall are planned, including an outside sign to keep residents informed of the happenings in Bridgeville. We are developing our own website. There will be a number of improvements to our waste water treatment facility. And again, thanks to Senator Thurman Adams and Representative Ben Ewing, a number of street and sidewalk improvements are planned.

In addition, a number of new ordinances have also been adopted. They include new regulations for swimming pools, abandoned or inoperable vehicles, signs, and new single and dual meter pits.

INUTES FROM THE MONTHLY OMMISSION MEETINGS:

PRIL 12, 2004:

There were 193 traffic arrests; 32 criminal arrests; and 3 trucks stopped in town.

was the 66th consecutive month without an NPDES violation at the WWTP.

Vational Water Works representatives held a seld demonstration on radio read water meter equipment on April 14th.

Recent vandalism in several neighborhoods was discussed with residents. The Commission assured the town will prosecute offenders.

Commissioner Jefferson and Chief Parsons will 3ddress the need throughout the community with

a assertive plan.

Mr. Nick Rocks, developer of Heritage Shores, announced the signing of golf course designer Mr. Arthur Hill. Phase I will include the grading of the golf course and the entire Heritage Shores community. Mr. Rocks advised a number of homes should be built and ready for occupancy by October, 2004.

-Sussex County Emergency Medical Services will relocate to the former visitor's center (Rt. 13) slong with the Delaware State Police (Troop 5). President Conaway, Commissioner Correll, and Town Manager Walls presented a check for \$2,000 to the Bridgeville Public Library on March 31st for the installation of new railings. Construction of the salt building is to begin the middle to end of May, 2004.

Ordinance No. A04-4-An Ordinance to Regulate Swimming Pools was adopted by the Commis sion. The Ordinance pertains to required fencing, self-latching gates, set backs, building

lines, and drainage from pools.

Ordinance No. A04-3: An Ordinance to Amend the Code by Adding Provisions Regulating Abandoned or Inoperable Vehicles was adopted by the Commission. If an order is issued for removal by the police, expenses will be the responsibility of the owner of the vehicle plus cost of prosecution.

The Commission adopted Ordinance No. A04-2:

-An Ordinance to Amend Zoning, Article III, by Regulating the Placement of Signs. The Ordinance allows no sign to be erected that will obstruct the view of motorists and pedestrians.

-Senator Adams and Rep. Ewing have introduced two bills for legislative action as requested by the town. The first being House Bill No. 372 which pertains to abatement of town property taxes, Section 27 of the Town Charter-the tax abatement would eliminate an exemption of ten years from taxation of town business establishments employing ten or more employees, annexing into town limits. The second bill is to change the title of "Town Treasurer", Section 20 of the Town Charter, to "Finance Director".

-During the recent Lions Club Variety Show, President Conaway was presented with the Annual Lions Club Citizen's Award for his dedicated service to the Town, County and State.

MAY 10, 2004:

-There were 223 traffic arrests for April.

-This was the 67th consecutive month at the WWTP without a NPDES violation.

-Town Commissioners, Town Manager Walls, and Public Works personnel met with representatives from National Water Works for a demonstration on radio read water meters on April 14th. Town Manager Walls and Water Superintendent Jones were in Rehoboth on April 27th to witness a radio field demonstration.

-Transformers were changed at Well #2-2D on May 5th.

-An application was submitted by Charles Royal for a conditional use to open at daycare and learning center at 219 First Street.

-Mr. Nick Rocks, developer of Heritage Shores, advised the actual starting date for the subdivision is scheduled for May 17, 2004 which includes the pump station and on-site work for 171 homes. The clubhouse will be 40,000 square feet with a tentative opening date for the clubhouse and golf course of Labor Day, September, 2005.

MAY MINUTES CON'T:

The "one-time limb burning" is scheduled for May 11, 2004 from 9:00 a.m. to 4:00 p.m.-drop off location will be the wastewater treatment facility.

-President Conaway, Commissioner Correll and Town Manager Walls attended the 2003 Governors Conservation Award and Living Soil Ceremony on April 22, 2004. Recipient for the Sussex County Urban Award were Robert and Casey Rauch of Robert D. Rauch & Associates, Inc. for their

Heritage Shores project.

-The General Assembly of The State of Delaware passed the request by the town to amend Chapter 27, Volume 51, Laws of Delaware, which repeals that portion of Section 27 of the Town Charter, pertaining to abatement of town property taxes. The tax abatement would eliminate an exemption of ten years from taxation of town business establishments employing ten or more employees annexing into town limits.

-The General Assembly of The State of Delaware passed House Bill No. 336 which amends the Town Charter, Chapter 237, changing the title of the town's "Treasurer" to "Finance Director". The title better describes the responsibilities of the

position.

-Presented for a first reading was an amendment to Chapter 128, Fees Established. The amendment would delete the amount of single meter pit of \$400 and dual meter pit of \$525 and increase the cost for single meter pit to \$525 and a dual meter pit to \$625. The second and final reading is scheduled for the June Commission meeting.

- -Town Manager Walls and Finance Director Savage presented the proposed FY-05 Budget for review during a workshop held at 5:30 p.m. on May 10th. President Conaway scheduled a Special Meeting for May 18, 2004 at 7:00 p.m. to introduce the proposed FY-05 budget; a Special Meeting was scheduled for June 1, 2004 for the adoption of the FY-05 Budget.
- -President Conaway and Town Manager Walls met with DNREC to discuss results of examinations and investigations relating to properties for spray irrigation. The properties reviewed under the contract should be capable of supporting the town's wastewater disposal needs through 2024.

-Based on the town's projected growth, the town will be able to treat, with 70% of the fields being acceptable and using a rate of one inch/week over a period of 34 weeks, the town will be able to apply 482 million gallons of treated wastewater on the fields. The WWTP plan forecasts a need of 322 million gallons by 2024, allowing for growth.

-A letter of complaint was received concerning two abandoned mobile homes located at 603 N. Cannon Street. The complaint was submitted to the Dangerous Building Inspection Committee for the inspection process per Ordinance A03-2.

-The Dangerous Building Inspection Committee is working with the town's attorney regarding the abandoned home located at 104 N. Main Street.

JUNE 14, 2004:

- -There were 602 traffic arrests reported for May.
- -On June 9 construction started on the new sewer force main. Teal Construction started laying sewer pipe at the WWTP.
- -The Consumer Confidence Report will be mailed to all residents approximately the week of June 14th.
- -The Commission adopted Ordinance No. A04-5 which amends the cost of meter pits as follows: Single-\$400 to \$525; Dual-\$500 to \$625.
- -Seaford will be hosting The Moving Wall, Vietnam Replica, starting September 14, 2004 at the Industrial Sports Complex.
- -Discussion was held on formulating a Neighborhood Crime Watch Program. A meeting has been scheduled for July 1, 2004. All residents are encourage to attend.
- -An application for a zoning change was submitted by Kathleen Passwaters for the property located at 418 Walnut Street. A conditional use request was submitted by Charles Royal for the property located at 219 First Street. The Commissioners have scheduled a meeting for Thursday, June 24, 2004 at 7:00 p.m. in the Town Hall.
- -The Dangerous Building Committee submitted a report concerning the property located at 603 North Cannon Street. Procedures will be taken to correct stated problems per Ordinance #A03-2.
- -The revitalization of the park located at the corner of Market and Main Streets will soon be under way—a new sign, flower beds, lighting, etc.

KIWANIS CLUB NEWS

"BARBECUE MAKE OVER"-The "old oak tree" at our barbecue stand has been cut down due to extensive ice storm damage and disease. It was estimated to be approximately 170+ years old.

In addition, a new 30' x 56' pavilion has been built at the BBQ area and hopefully will provide for the needs of our patrons.

The existing BBQ pit and shelter along with the existing storage building received improvements also. A 9 1/2 foot square walk-in cooler has been purchased from the Woodbridge School District and is now in service.

The BBQ began in 1961 by the Greenwood Kiwanis Club at a location near the fire tower at the state line on Rt. 404. It moved to the present location in 1963. Sales were so good, the Greenwood Club invited the Bridgeville Kiwanis Club to share one half of the season, which now operates from the first weekend in May and every weekend through September. The Greenwood Kiwanis Club turned in their charter in 1991, and the Bridgeville Kiwanis members have operated the chicken BBQ ever since.

Few changes have been made in the forty plus years; but as we enter this new century we need to move forward to serve our customers better and hopefully improved the looks of our facility.

At the present time, the Club shares the BBQ season on weekends with 13 community organizations to assist them with their fund raising efforts. These organizations must support other children and youth programs in the Bridgeville/Greenwood area.

The Club has, this year, installed new American flags along the main streets of town. This project started in the spring of 1991 as an outward expression of one of the objects of Kiwanis International. "To co-operate in creating and maintaining that sound public opinion and high idealism which make possible the increase of righteousness, justice, patriotism and good will".

The Club sponsored a Home Decorating Contest on Memorial Day. This project was a way to help us remember the true meaning of the day...a special time set aside by our nation to recognize those persons that sacrificed their lives so that we may continue to enjoy freedom everyday.

HIGHLIGHTS OF THE TOWN OF BRIDGEVILLE FISCAL 2005 BUDGET

This budget continues to reflect the growth of The Town of Bridgeville and becomes the largest operational budget in our Town's history. This budget trend will continue as Heritage Shores is developed.

No property tax increases are recommended in this budget and in fact, the budget reflects a decrease in taxes and fees paid by the residents of Bridgeville.

This budget eliminates the \$15 Capitation Tax paid by residents of Bridgeville. In addition, it recommends a reduction of the \$7 water meter monthly fee to \$3.50. If these recommendations are adopted, the average family will see a total reduction of \$72 this Fiscal Year in fees and taxes. There has not been a reduction in taxes and fees in a number of years.

This budget reflects the largest amount of carry over funds from a past fiscal year, \$100,000.

This budget reflects the efforts of the Bridgeille's Town Manager, Mrs. Bonnie Walls, and Bridgeville's Finance Director, Mr. Jesse Savage.

This budget reflects the beginning effect of the new Bridgeville subdivision on increased funding for emergency services. The budget projects a \$33,750 grant to the Bridgeville Volunteer Fire Company.

This budget has a minimum of about \$104,985 for contingencies.

This budget funds five full time police officers, Chief of Police, and the addition of a sixth full time officer later this fiscal year. Two new police cars are also provided for in this budget.

This budget contains no interest or principal payments to Greenwood Trust Company. The \$200,000 loan, borrowed by a previous Commission, has been repaid.

This budget continues the grant funding initiated in the Fiscal 2002 Budget for community based organizations including the Bridgeville Volunteer Fire Company, the Bridgeville Library, the Bridgeville Historical Society, the Noodbridge Little League, and the Apple-Scrapple Festival. A small grant to the Western Sussex Boys and Girls Club is also provided for

those who take part in their programs.

This budget provides funds for merit raises for Town employees. Funds are also being provided by adding Blood Bank memberships for Town employees.

This budget continues the ten year maintenance program for the water tower, but at a reduction in cost.

The code book for the town is being updated this year. This budget continues funding updates so that our code book will continue to be current.

This budget funds a number of improvements in the Town Hall including a new informational sign, a town promotional brochure, new carpet, painting, a new telephone system, upgrading the utility software program, and our very own web site.

This budget provides funding to begin the state mandated fluoridation program in our water system.

This budget provides funding for a number of improvements in our wastewater facility—an auxiliary generator, an RBC blower, a pump for the chlorine building, an air compressor, a sludge pump, and painting of the three block buildings.

There will continue to be repairs/repaying to town streets and sidewalks as a result of grants provided by Senator Thurman Adams, Jr. and Representative J. Benjamin Ewing.






