From the President's Desk



The Second Annual Bridgeville Charity Golf Tournament was again a great success. Under the Chairmanship of Ed Lewandowski, the tournament raised \$9,000 each for the Bridgeville Senior Center, the Bridgeville Lions Club and the Bridgeville Kiwanis Foundation. A hearty thanks for a job well done to Ed and his committee, and to all who made this tournament one of the premiere golfing events in Delaware.

In an effort to control those unlicensed vendors who show up unannounced throughout the Town, we now have a new Ordinance in place to regulate peddling and soliciting in Town limits. The new Ordinance does not affect those legitimate school and charity groups that go door to door, but does require that they notify the Town so that we are aware of their presence.

Although Bridgeville's finances continue to be the envy of other municipalities, the Commission has asked our Town Manager and Finance Director to review our Fiscal 2009 Budget with an eye to trimming that budget by 5%. We had prepared for this downturn in our revenues already, but believe that prudent planning requires us to look at our situation so that we can continue to weather the depression in which our country finds itself.

We have hired three new police cadets who are presently in training in Dover. These men are Mr. Richard Baker, Mr. Ryan Hogan and Mr. John McQuown. They are scheduled to graduate in April 2009 and will join our force at that time. These additions bring our force up to our budgeted authorization. Each of these men, plus our new patrolman, Aaron Bonniwell, have signed five-year contracts with the Town of Bridgeville.

The Town Commission is very much concerned with the condition of the Jack Lewis Mural on the wall of the Dollar General Store building. We hope to take steps to prevent further deterioration of this historic painting. More on this later as our plans materialize.

We are hopeful that the new Bridgeville Wastewater facility, located on Apple Tree Road to the east of Town, will be operational in December. We anticipate State approval in early December 2008. Since we will not need this facility until next spring, we will use the winter months as training for our employees so that when we begin to spray on this site, all the problems with start-up will have been worked out.

Negotiations continue between Bridgeville and Greenwood as to a new long term wastewater agreement to replace the contract signed in 1989. The new agreement will streamline that original document and cover times as they are now.

The Commissioners and Staff of the Town of Bridgeville would like to take this opportunity to extend to all the residents of our Town a very Merry Christmas, Happy Hanukkah, Happy Kwanzaa and also a Happy New Year to all. May the coming year bring the promise of Christmas to our great country and hopefully, peace on earth and good will to all.

Minutes from the Monthly Commission Meetings

October 6, 2008

September Traffic Arrests: 71 Criminal Arrests: 30

Thirteen building permits were issued in September bringing revenue of \$2,480.00. Three certificates of occupancy for new homes were issued and three buildings were condemned.

Five untagged or inoperable vehicles were turned over to the Bridgeville Police Department for action.

Two water meters were installed at Heritage Shores and one water/sewer inspection was completed.

Well 6 at Heritage Shores should soon be in service after the Office of Drinking Water gives final approval for start-up.

There were no violations of the NPDES permit at the Wastewater Treatment Plant in September.

The Phase One sewer at Heritage Shores has had a final inspection by engineers and the Town, and has been accepted by the Town.

The Commission presented a \$1,000 yearly donation to the Bridgeville Historical Society, represented by Mr. Howard Hardesty and Mr. Charles Hawk.

The Town and Lindenmere developer, Bridgeville Holdings L.L.C., are investigating the feasibility of starting construction on the development with the delay of a new elevated tank until Phase II. Phase I of the project would begin with moderately-priced housing.

September 12th marked the successful start-up of the spray irrigation pumping stations.

Ordinance A08-13 was adopted, allowing residents to renew a building permit for a maximum charge of \$50. According to code, work must begin within six months of the date of issuance or the permit will expire.

President Conaway requested that Town Manager Walls investigate the preservation of the Jack Lewis Mural, painted on the side of the Dollar General Store in Bridgeville. Other Jack Lewis paintings which would also benefit from preservation include a large mural at the library and at the high school.

It was reported the Second Annual Charity Golf Tournament has raised over \$6,000 for each of the three charities who will benefit from the proceeds.

November 10, 2008

October Traffic Arrests: 89 Criminal Arrests: 13

Eight building permits were issued in October bringing revenue of \$1,275.50.

Three untagged or inoperable vehicles were turned over to the Bridgeville Police Department for action.

Two water/sewer inspections were completed at Heritage Shores. Meters installed now total 525.

A telephone circuit was installed to the Heritage Shores pump station by Verizon. The control panel at the Wastewater Treatment Plant now has communication with all well sites and the sewage pump station.

The Town continues to replace older, individually-read water meters with radio read mxu's. Thirty were installed at Elizabeth Landing Annex in October. This new technology saves a great deal of time for our Public Works Department.

All Wastewater operators received factory training for start-up/operation of the new Somat sludge de-watering equipment.

The Commission proclaimed November 11th as Veterans Day in Bridgeville.

The Police Department received a DUI Enforcement Grant for checkpoints on October 31st and November 1st.

Storm drains were cleaned throughout Town.

Branch piles at the Wastewater Treatment Plant from the Town Clean-Up Day were processed with a rented chipper.

Royal Farms was granted an additional 7 EDU's (units of water/wastewater usage) for their business on Route 13.

The Commission advised a tribute event will take place November 22nd to honor outgoing Sussex County Councilmen Jones, Dukes and Rogers for their years of service.

The Wastewater Treatment Plant received test results of the annual EPA-required "in-house" laboratory procedures. All submitted test results were "acceptable." Superintendent Mowbray extends his thanks to Delaware Rural Water Wastewater Circuit Rider, Mrs. Rose Cline, for her assistance during this annual testing. She is always willing to help Bridgeville.

The Commission discussed the possibility of entering the state's Police Pension Fund program for our police officers.

Golf Tournament Chairman Ed Lewandowski presented checks to the Senior Center, Lions Club and Kiwanis Foundation, bringing to \$9,000 the amount of money each organization received from the proceeds of the 2nd Annual Golf Tournament.



Town Manager's Report



Mark your calendars for April 4, 2009! This is the date of the Third Annual "Spring into Health" Community Walk. The event will again be held at the Woodbridge Athletic Complex beginning at 9:00 AM. The Sussex Child Health Promotion Coalition; the Towns of Bridgeville, Seaford, Laurel, Georgetown and Delmar; and Nemours Health and Prevention Services, have all joined together for a third year to promote this vital Walk. The goal of the Community Walk is to continue the efforts to help Delaware's children become the healthiest in the nation. We will strive to raise awareness on the prevention of childhood obesity and early onset of diabetes through the promotion of healthy lifestyles. An important goal of the Walk is to familiarize everyone with the "5-2-1 Almost None" philosophy of eating at least 5 fruits and vegetables per day, limiting screen time to 2 hours or less and increasing physical activity to 1 hour per day, while eliminating sugared beverages. Please plan to join us on April 4th.

Southern Delaware Tourism annually presents a Recognition Award to an individual or group that has made an outstanding and significant contribution to tourism in Sussex County. The contribution must demonstrate efforts made to create or enhance a Sussex County tourism product in order to attract visitors to the county and positively impact the local economy. The Town of Bridgeville proudly and enthusiastically recommended consideration of the Bridgeville Apple Scrapple Festival and placed them in nomination for the award. We were recently

notified that the Bridgeville Apple Scrapple Festival is the 2008 Recognition Award recipient! Our thanks and congratulations to the Festival committee for seventeen years of hard work and dedication.

Adding to what President Conaway reported concerning peddling and soliciting in Town, we have made some changes to the Ordinance that we believe will be beneficial. Any business that wishes to sell door-to-door within Town limits must apply for a permit at Town Hall, providing a variety of documentation to qualify. The yearly permit fee is \$50. (Non-profit organizations must apply for a free permit.) Hours have been adjusted to 10 AM - 9 PM, allowing ice cream trucks the opportunity to sell at summer Little League games. All residents are encouraged to request to see the Town permit of any solicitor who comes to their door, as they are required to carry their permit. In addition, the Bridgeville Police Department is informed of all solicitors in Town.

The Commissioners and employees are collecting canned goods; these are added to the donations from Caroling in the Park for Christmas baskets to the needy in our community. Please consider donating food items to the Town Hall to make someone's Christmas a little brighter this year. Donations will be accepted through Friday, December 12th.

Christmas Tree Recycling

The Department of Natural Resources and Environmental Control reports that they will again hold a Christmas Tree Recycling program for down-state parks. Killens Pond in Felton, Trap Pond in Laurel and Cape Henlopen in Lewes will accept Christmas trees from December 26th through January 19th for recycling. All trees must be free of ornaments and tinsel. The program is for families only, no commercial haulers or businesses may use the service. To help offset operating costs the state parks will have a donation box recommending \$2.00 per tree.

Bridgeville Election Voting Districts

The Town of Bridgeville has joined many other municipalities in establishing Election Voting Districts for Commission Elections. Each property within Town limits has been assigned to one of 5 districts. Registered voters will be able to vote on a roster of candidates who live within their district and will represent that district as a Bridgeville Commissioner.

Voting by district began with the March 2008 Municipal Election, when Commissioner Ruth Skala was elected to a two-year term in District 2. Incumbent Commissioners Earl Greason (District 1) and Patricia Correll (District 3) were returned to their seats for two-year terms, with no contest.

At the upcoming March 2009 Municipal Election, the Commission seats held currently by Commissioner Joseph Conaway (District 4) and William Jefferson (District 5) will

be up for election. Candidates for these two Commission seats will be vying for a two-year term as a Commissioner of Bridgeville.

Election Voting District assignments were mailed to registered voters prior to the March 2008 election. Voters registering since the last election will also be informed of their district by mail before the March 7, 2009 election.

Every resident of the Town who is 18 years of age is eligible to vote in his/her Voting District election, provided he/she has registered on the "Books of Registered Voters" of the Town of Bridgeville.

If you are uncertain of your voting district, please contact the Bridgeville Town Hall, weekdays from 8:30 AM to 4:30 PM.

Snow Reminders

Shoveling

Snow and/or ice must be removed within twenty-four (24) hours after snow/ice has ceased to fall, according to Town Code. The owner or occupant of any building or lot abutting a public sidewalk is responsible to keep it clear of snow/ice.

Plowing /Salting of Roads

Residents having access to their yard from an alleyway must park their vehicles there. If a driveway does not exist, all residents must move vehicles to the even-numbered side of the street as soon as snow/ice begins to fall. When the even-numbered side has been cleared of snow/ice, residents must move vehicles to the odd-numbered side of the street. This will allow the Town to clear the streets completely without the need for residents to shovel their respective parking space.

Do not shovel snow/ice into the street. With everyone's cooperation, the snow/ice removal will be accomplished efficiently.

In order for your letter carrier to deliver your mail promptly and provide you with uninterrupted services, residents must clear snow/ice from walkways and the approach to the mailbox.
