Snow Reminders

Shoveling Snow/ice must be removed within twenty-four (24) hours of it ceasing to accumulate, according to Town Code. The owner or occupant of any building or lot abutting a public sidewalk is responsible to keep it clear of snow/ice.

Additionally, In order for your letter carrier to deliver your mail promptly and provide you with uninterrupted services, residents must clear the approach to their mailbox.



If you are out of Town for an extended period of time during the winter months, you must make arrangements for your sidewalks to be shoveled in your absence.

Snow Plowing /Salting of Roads When snow begins to fall, residents having access to their yard from an alleyway must park their vehicles there. If a driveway does not exist, all residents must move vehicles to the even-numbered side of the street. When the odd-numbered side of the street has been cleared of snow/ice, residents must move vehicles to the odd-numbered side of the street. This will allow the Town to clear the streets completely and efficiently, without the need for residents to shovel their respective parking spaces.

Minutes from the Monthly Commission Meetings

October / November / December 2011

The American Bus Association, representing the Motor Coach Tour and Travel Industry, has named both Punkin Chunkin and the Apple Scrapple Festival in their 2012 "Top 100 Events in North America."

The Town received \$160,000 in American Recovery and Reinvestment Act funds to replace well pumps at wells #2 and #5. The money was also used for lighting replacement and new windows/doors in municipal buildings.

Town management and employees had the opportunity to meet with Senator Tom Carper concerning the future of Bridgeville's wastewater plant. The Town is working with legislators and the state to determine upgrade costs for Town compliance with increasing wastewater regulations.

Child Safety Seat Inspections were conducted at the Fire Hall in September, spearheaded by Commissioner McCarron from the Fire Company and Police Chief Longo.

The Commission granted a conditional use at 101 Elliott Drive to Mr. and Mrs. Jeff Tull for a two-family dwelling in a single-family residential district.

High School Senior Amanda Reed was honored with a Proclamation regarding her success in posting No Smoking signs at the Sanctuary for Kids Park. She has also partnered with the "Kick Butts Generation" and hosted a booth at the Apple Scrapple Festival to curb the increase of youth smoking. Ms. Reed's senior project concerns the effects of land and air pollution on the human body.

The Town Commission recognized Mrs. Bonnie Workman for her leadership of the Apple Scrapple Festival over the past 20 years; she has been Chairman for the past 17 years. Mrs. Workman thanked the Town for their tremendous support of the festival.

Bridgeville entered into a three-year contract with Waste Management (WM) for solid waste and recycling services. WM took over quarterly billing services from the Town in November.

The Police Department collected 99 pounds of drugs during the second Prescription Drug Take-Back Initiative, in partnership with the Bridgeville Fire Company. The Police Department has also received a \$3,700 grant for DUI patrols in Town.

President Correll and Commissioner Tassone led a group of resident volunteers to beautify the Town by planting winter pansies in the Town Center District.

Bridgeville was approved for a \$75,000 grant from the U.S. Fish and Wildlife Foundation to fund a Master Plan and other planning projects for future wastewater facility development.

The Commission approved the reappointments of residents to Town Boards. Ms. Ruth Ann Tull and current Chairman, Mr. Bill Atwood, were reappointed to the Planning and Zoning Commission. Reverend Dale Brown and Mr. George Hardesty were reappointed to the Board of Adjustment. These are 3-year terms.

Retiring Sussex County Administrator, Mr. David Baker, was invited to the December Commission meeting to accept a Resolution in his honor, praising him for his numerous accomplishments over his 35 years of service to Sussex County as Administrator and Finance Director.

Mr. Rick Tull from the accounting firm Lank, Johnson and Tull presented the annual audit. He advised Bridgeville has a fairly good balance sheet for a small Town and believes the Town can be proud of the results of the audit.

Town Manager's Report

As every resident is aware, we are now entering the winter season when the threat of snowfall is common with every low pressure system. The good news is that your Street Superintendent, Rick Passwaters, is prepared with plenty of salt for any type of inclement weather event. Superintendent Passwaters has also been busy completing a new curb on North Cannon Street and finalizing the DelDOT ADA curb ramp replacement project on Market Street, which is just in time for DelDOT to begin the repaving project on North Main Street from Town Hall to Route 13 in late March. This project will also include a traffic signal modification.

From the Water Department, Mr. Scott Kimball, our new Superintendent, is meeting residents, installing meters, monitoring the Well House pump/motor replacement project and continuing to learn his new position. Scott was hired in November 2011; please make him feel welcome.

The Bridgeville Wastewater Department, led by Mr. Jeff Collins and Mr. Phillip Mowbray, has been busy coordinating several energy reduction projects, such as replacement of the windows and doors at the wastewater treatment facility, installation of two new rotating biological contactors and the daily maintenance that is needed to operate a high level sewage facility like the one in Bridgeville. Since the winter season has been mild to-date, Jeff and Phillip have been utilizing the spray rigs at the Tatman farm, five miles east of Town, to dispose of treated

wastewater. Speaking of the spray site, the Town Commission approved a grant application to DNREC for replacement of the effluent line from the wastewater treatment facility to the Redden Road discharge site. The line experienced several leaks in 2011 and we need to move forward with replacing the infrastructure.

Other exciting news includes a redesigned Town Website: www.bridgeville.delaware.gov. The site will feature up-to-date meeting information, utility rates, emergency phone numbers, and a host of interactive menus for everything Town related. This is a work in progress.

Regarding the Town Code, the Commission passed two Ordinances on January 9th. First, a Contracting License Ordinance was passed requiring all contractors who work within Town limits to pay a \$50 yearly fee. Please contact Code Enforcement Officer Butler for more information, or download the adopted Ordinance from the Town Website. Second, the Commission passed a Redistricting Ordinance which featured a new election district map. Public notices will be sent to residents whose election districts have changed in the redistricting process. Please contact Town Hall for more information.

Lastly, the Town of Bridgeville sparkled during the Christmas holidays and I am very fortunate to be able to work with a dedicated and hard working group of employees and passionate Commissioners.

Town Redistricting For Municipal Elections

Bridgeville maintains five Election Voting Districts and was required to redistrict within one year of the 2010 Decennial Census. With the assistance of the Town Solicitor, the University of Delaware Center for Applied Demography and Survey Research, a committee of five voting district representatives and public comment, the Commissioners of Bridgeville made changes to the Town's Election Districts.

Previous Election District populations were as follows:

District #1 - 289 District #2 - 457 District #3 - 255 District #4 - 409 District #5 - 234

Revised Election District populations are as follows:

District #1 - 379 District #2 - 446 District #3 - 399 District #4 - 375 District #5 - 378

Public notices will be sent to residents whose districts have changed in the redistricting process; however, if you are uncertain of your Election Voting District for the upcoming election, please call or stop by Town Hall for assistance.

Code Updates

Unlicensed Vehicles

Per Town Code, "on any residentially zoned property, a vehicle or a trailer without valid license plates shall be parked or stored in a completely enclosed building."

All unlicensed vehicles must either 1) adhere to the above code, 2) be removed from Town or 3) be tagged by the Delaware Department of Motor Vehicles by Tuesday, January 31st.

911 Addressing

Bridgeville is continuing to cooperate with Sussex County in requiring all buildings to display their 911 address properly. This is imperative to your safety, should emergency services need to locate your home!

- On a Mailbox - 3 inch tall numbers
- On a House - 4 inch tall numbers
- On a Large Commercial Building - 10 inch tall numbers

The fine process will be instituted on February 1, 2012.

Contractor / Subcontractor Licensing

A licensing process has been approved by the Town Commissioners for all contractors/subcontractors working in Town and is now in effect. This does not include contractors performing work or providing materials for the repair, restoration or maintenance of previously existing contracting work.


