MINUTES OF THE COMMISSION.....

JULY 12, 1999:

- Complaint received from residents concerning run down piece of property on Oak Street.
- Bridgeville to receive \$30,000 for housing rehabilitation from the Community Development Block Grant Fund.
- Letter of complaint from residents on Elm Street regarding the tall grass and weeds on property behind their homes. The Town Office did notify the owner of said property.
- Total traffic arrests for month of June was 240. New gray colored police car arrived about three weeks ago (purchased through grant money).
- WWTP received four septic haulers for a revenue of \$1,790.
- The three on-going projects at the WWTP are: the up-grade study for the TMDL situation; the proposal to repair the pothole on Walnut & Railroad Avenue; and the proposal to repair the sewer pipe line near the plant entrance.
- Street Commissioner Sipple reported the repaving project by Delmarva Paving was to start June 1st (????). Also there is a storm drain that needs attention as soon as possible. The new dump truck arrived the first week of July.
- Commission voted to accept the bid from Hopkins Construction to repair the pipe line. Cost being \$13,087 which will be taken from the Sewer Sinking Fund.
- Discussion was held on the Housing and Building Code Enforcement and who will be the enforcement code officer. Tabled until August meeting.
- Commission voted to have Code Publisher Co. update the Code Book. Cost between \$700 and \$900.0
- The noise ordinance tabled until all Commissioners had time to review the proposed ordinance.
- Commission voted to amend the Town Code to include a Planning Commission. First reading to take place at the August meeting.

- Several residents discussed their concern over trucks still going through Town, and our police dept. not stopping them for the violation.
- Several residents registered complaint over the many abandoned homes in Town. Commissioners told them they are working on an ordinance that would eliminate such problems.
- Officer Kevin Wix was hired as a full-time employee of the Town.
- Four employees received merit raises as of July 1st.

AUGUST 9, 1999:

- There were 391 traffic arrests for the month of July.
- We had three septic haulers for a revenue of \$1,776.
- WWTP plant took a lightning hit and several pieces of equipment were damaged. Some will be replaced under warranty.
- Received complaints from residents concerning the odor that comes from Cannon Cold Storage-residents told to call DRNEC because the Commission cannot file the complaint.
- Repaving of several alleys and streets to start August 18.
- Several residents complained about people driving straight through Elm Street-owner of land next to the end of Elm Street gave permission to post "no trespassing" signs. The residents asked the Commissioners to place stakes out at the end of the street.
- The first reading of Ordinance #99-2; Vehicle Noise Ordinance. Second reading and vote will take place at the September meeting.
- Commissioners voted to hire a part-time Code Enforcement Officer as soon as possible. The new officer will be responsible for getting vacant homes/building either repaired or taken down.
- Discussion was held concerning 103 S. Main Street. The Sussex County Federal Credit Union would like to remain in the building....

Cont.-Aug. minutes:

- President Dalton will negotiate with the new credit union.
- President Dalton said calls were made from the office recently to check on the elderly in Town during the recent "heat" wave.
- First reading was held on Ordinance #99-1; An ordinance to amend Chapter 234 of the Code of Bridgeville relating to zoning (establishing a Planning Commission).
- Mr. Tim Banks presented his vision of opening a drug and alcohol treatment home at 105 S Main Street. His non-profit organization is called Restoration Outreach. After much discussion, Mr. Banks was asked to prepare a business plan and a financial statement and present it at an open meeting.
- Commissioner Sipple reported the hole on Jacobs Avenue would be repaired next week.
- Several residents complained about rats being seen on N. Main Street. They requested the Commissioners to get the problem resolved as soon as possible.
- Mr. Bill Flynn suggested that all of John Street be made a one-way street.
- President Dalton reported that the materials needed to repair the pipes at Walnut & Railroad Avenue have been ordered.
- Mr. Phillip Davis thanked the members of the Commission for taking a stand on the Waste Management Project.

SEPTEMBER 13, 1999:

- There were 309 traffic arrests for the month of August.
- We had three septic haulers for a revenue of \$1,856.60. Hopkins Const. turned in the lowest bid (\$13,087) for the repair of the stream-crossing sewer line project at N. Main St.
- The Town's Municipal Street Aid Fund this year will be \$56,843.21.
- Several letters have been sent to homeowners who are not keeping their

yards mowed. Per Town Code it not cut within 10 days after receiving notice, the Town will have it mowed and billed, plus administrative cost, to said homeowner.

- Mr. Rick Tull presented the audit for the sixteen month period.
- The first reading of the Vehicle Noise Ordinance, Ord. #99-2 was held. Second reading & vote will take place at the Oct. meeting.
- The second reading and adoption of Ordinance #99-1, Planning Commission. Tabled until October was the selection of the five member Commission to serve.
- It was decided to hold Trick or Treat Night on, Sat., Oct. 30, 1999 from 6-8 PM only.
- Commission approved to allow Chief Parsons to apply for a \$9,000.00 Criminal Justice Block Grant to use towards police vehicles.
- The old dump truck has been sold for \$4,000.00.
- Commission received several complaints from citizens about dogs over running the Town. Commission promised to look into the problem.
- Mrs. Joanne Conaway commended the Commissioners on the recently repaved alleys and streets.
- DELDOT has approved the closing of Market Street on Sat., Oct. 9th, from 8-5 PM. For safety reasons the Town Commission and the Apple-Scrapple Committee decided to take this measure.

As you have probably noticed we received some more legislative funds and the following streets have recently been paved: Elm, Emory, John, part of Mill Street, Maple and Pine Alleys. Thanks to Sen. Adams and Rep. Ewing our Town is looking great!

The Sussex County Boot Camp workers have helped alot with the cleaning along our street edges, storm drains, etc. If we had them ore often we would be in great shape! Being we don't, lets all do our part to keep Bridgeville clean and make us really proud of our Town.

FROM THE PRESIDENT'S DESK.....



Now we know what a "Hundred Year Flood" is like in Bridgeville, and we came through it very well. I want to say a special thanks to our town employees for their outstanding service through this emergency. Phil Mowbray and Rick Passwaters worked all day and into the night maintaining the operation of the wastewater plant.

Alma Fleetwood kept everyone calm who called town hall to report the water rising, and she was an indispensable help to this office as we tracked the storm and tried to stay ahead of the needs of the community.

Devotion to duty was exemplified in Chief Allen Parsons, not only did he man the phones at the station until Michael and Office Wix arrived to relieve him, but he then took up a shovel and rake to go out and clean storm drain grates to keep the water flowing.

To all we say "Job Well Done, Thank You."

Overall we fared rather well from the nearly eleven inches of rain with only minor damage at the plant and North Cannon Street (Frog Harbor area) weakened to the point it will have to be rebuilt. We are told the Delaware and Federal Emergency Management Agencies will assist financially in restoring these services.

On the development front we have two items of importance. First we were successful in getting DELDOT to change their designation of Rt. 13 to an investment area so that we will get support from them for development of the area from the diner all the way to the Redden Road. This means that we will have the service roads necessary to insure that the area does not develop improperly. We are forming a working group to work with DELDOT to insure the Town's needs are considered in all the decisions they make for the roads and highways around Town.

Secondly, the Commissioners have named the members of the Bridgeville Planning Commission. Named to serve are Jack Dalton and Willie Pierce representing the Commissioners, and Charles Hawk, Howard Hardesty, John Shockley, Kevin Carson and Jeff Scott residents. The Commission is charged with the responsibility of developing a land use plan for the Town. The recommendations of this Commission will go before the Board of Adjustments before being approved by the Commissioners. This will be of major importance to the Town in the face of the pending development we are being asked to approve and facilitate in the near future.

Finally, we look forward to a fabulous Apple-Scrapple Festival this year as I have seen how hard they are working and all the new and exciting attractions they have planned. In advance, thanks to all who serve on the committee for your hard work and devotion to our community.

HALLOWEEN PROVISIONS

CHAPTER 114

#114-1 Halloween Curfew: three days before and three days after Halloween it shall be unlawful for any children under the age of 18 years to be on the street or alleys in the Town of Bridgeville after 9:00 PM, unless accompanied by one or both parents. Any children out after the curfew hour will be in violation of this article.

#114-2 Parental Responsibility: the parents will be responsible to see that their child or children are off the streets before the hour established in this article.

#114-3 Designated Trick or Treat Nite. It shall be unlawful for any child to be trick or treating other than the night selected as Halloween. Because of Halloween falling on Sunday, trick or treat night will be SAT. OCTOBER 30th, for children twelve and under only, 6-8 PM.

#114-5 Vandalism Prohibited: it shall be unlawful for anyone to deface or destroy personal or public property.

#114-6 Throwing Objects Prohibited: it shall be unlawful to throw water balloons, apples, pumpkins or any other objects at any moving or parked vehicles or at any window, doors or people.

#114-7 Entering Cemetery Prohibited: It shall be unlawful for anyone to be in the cemetery after the hour of darkness.

#114-8 Importing Trick or Treat Prohibited: it shall be unlawful for any parent or friend whose residence is not that of Bridgeville to bring their child/children to the Town of Bridgeville so that the child/children can go trick or treating.

#114-9 Violation and Penalties: Whoever violates any section of this article of the Town of Bridgeville shall be fined not less than \$5.00 nor more than \$25.00. If the second

offense shall occur within 72 hours he/she shall be fined not less than \$25.00 nor more than \$50.00, and the parents shall be responsible for their child's behavior and all fines.

SHORTCUTS FOR PRACTICAL PEOPLE.....

- * Prepare your snow shovel for winter with a coat of floor wax. The wax helps prevent the scoop from rusting, and also makes the snow slide off without sticking.
- * It's easy to read a rain gauge if you put a few drops of food coloring in the tube. Even if the colored water dries up, there is enough residue to help read the next rainfall.
- * To keep shower doors shiny and clear, use a soft cloth moistened with baby oil. It prevents scum buildup from dirt and soap. And hard water spots won't appear for several months.
- * If you find the tops are sticking to your tubes of glue, try rubbing a little petroleum jelly around the rim. Works on paint can lids, too.


