New Business-Ordinance to Amend the Updated 2018 Comprehensive Plan for the Town of Bridgeville to Substitute Future Land Use Maps M 010-20 Town Manager Savage stated that this item is something that came as a result of the property owner of the parcel that is just south of Food Lion. Mr. Savage stated that they came to the Town with a proposed plan and it did not fit with the Commercial zoning. Mr. Savage stated that they are proposing about 180 apartments so mixed use is what would fix that parcel. Mr. Savage stated that it is still consistent with what the Commission discussed about the Comprehensive plan. Mr. Savage stated that the Commercial property could be on Rt. 13 and the residential side would be on Rt. 404. Mr. Savage stated that it went through the PLUS process and received three (3) comments. Mr. Savage stated that this has gone through Planning and Zoning and there is a recommendation for approval.

Public Hearing Opened at 7:12. Mr. Costello,7 Harlequin Loop, asked where the parcel is located at. Mr. Savage stated that it is the parcel south of the Town Homes on the highway and Troop 7, behind the produce center but not directly across from Heritage Shores. Mr. Costello asked what the projected project is consisting of. Mr. Savage stated that it is mixed use, retail stores, a hotel, and around 180 market rate apartments. Mr. Costello asked if this is what the original project for the parcel was. Town Manager Savage stated, yes, it is when it was annexed in 13 years ago. Mr. Costello asked if they would be connected to sewer. Mr. Savage

Mr. Savage stated that is a 0.2% decrease. Mr. Savage stated that on the revenue side, the Town will show a revenue of \$67,000, showing a surplus.

New Business-Grant-inaid/Donations Town Manager Savage stated that he does not have any requests.

Commissioner Smith introduced an Ordinance that would amend Chapter 217 of the Code of the Town of Bridgeville as it relates to Vacant Building Registration.

Commissioner Smith introduced an Ordinance to Amend the Bridgeville Code to Provide of the Appointment and Removal of a Town Manager.
