WHEREAS, the Commissioners held a workshop on March 25, 2019, to review the capital improvements recommended for Fiscal Year 2019, as submitted by Department Superintendents and by the Town Manager; and,

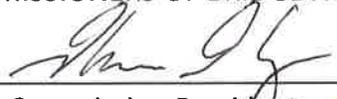
