Call to Order	The meeting was called to order by Commission President Carey. The pledge of allegiance was led by Commissioner Smith. The invocation was given by Commissioner Saunders.

Correspondence	Town Manager DeBussy stated that they Town received a Thank you with a Newspaper article from the Heritage Shores Military Club.

Accounts Payable- The Town paid bills totaling \$1,402,664 during the month of September which included a check to M&T Trust for Heritage Shores Taxes for \$1,161,825.

Town Reports Town department reports were reviewed by the Commissioners.

Town Manager DeBussy gave a brief update on the Wastewater Project.

President Carey thanked the Town staff for pulling off their Halloween Project. President Carey also congratulated Town Clerk Ashley Walls for completing her first year of the Clerk's Program.

A public comment period was held and the following spoke:

William Teagle: 514 N. Cannon Street- Mr. Teagle asked about water flow on the street because there is no drainage. Town Manager DeBussy stated that the Town's Engineer will need to get involved and that she has reached out to Matt Carter from the T Squared Center at the University of Delaware to do a road assessment and sidewalk assessment. Commissioner Saunders stated that she has a photo of the water as well.

George Burrows: 41 Ruddy Duck- Mr. Burrows just wanted to thank the Town for addressing his sink whole issue.

Kalissa Horn: 114 First Street- Ms. Horn stated that they have an ongoing dog running loose issue and that there are even chickens. Chief Parker stated that he is aware, and they contact animal control regarding these animals. Chief Parker stated that they are still trying to figure out some of the owners of these animals. Ms. Horne stated that she is just afraid someone is going to get hurt and that she has the information regarding the owners.

Marian Smack- 21 Gum Street: Ms. Smack stated that she has been going to her father's house, Ralph Smack, 4 Gum street and that the neighbor at 27 Gum Street has a dog that will chase you. Ms. Smack also asked about if someone could dig path when it snows back to her father's house. President Carey stated asked Ms. Smack to contact the Town Manager and she can give her information regarding groups that help with snow plowing.
