1" = 4,800'

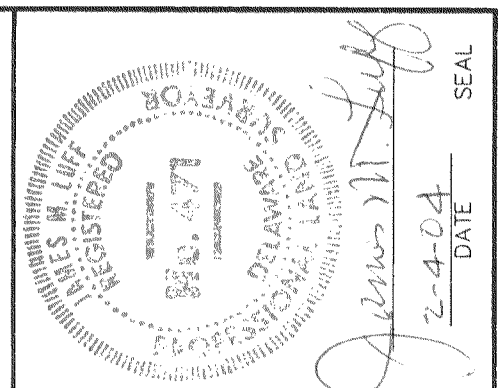
