

Jesse:

This letter is to formally request final acceptance of the roads and associated infrastructure of Phases 2B of the Heritage Shores Community for maintenance by the Town of Bridgeville.

The streets (as graphically indicated on the Heritage Shores Right-of-Way Dedication plan, Attachment "A", dated November 11, 2016) included in the Phase 2B portion of the community consisting of Blue Heron Court, White Pelican Court, Snowy Egret Court, Ruddy Duck Drive, and Canvasback Circle from Heritage Shores Circle to Widgeon Way.

Per your request, Passwaters Farm, LLC will provide the following extended warranties: Roadway asphalt and concrete curb for a period of one year from Town acceptance.

Specifically not included in the improvements with Phase 2B are the sidewalks associated with the streets, as it is our understanding the sidewalks bordering individual homeowner's property will be the responsibility of the individual homeowner for repair and maintenance, while any sidewalk bordering HOA property will be the responsibility of the HOA for maintenance and repair.

Additionally, Champions Drive built as part of Phase 3A (from Heritage Shores Circle to lots 521 and 558) shall carry a 2 year warranty on road and curb after Town acceptance.

Furthermore, Whistling Duck Drive shall carry an extended warranty on where the last remaining home aren't built (lots 388, 373-384 inclusive). The developer will be responsible for any repairs to utilities, sidewalks, curb, or street asphalt, upon the completion of each home.
