# **MINUTES**

MARCH 14, 2022 – 7:00 P.M. ZOOM ONLY

A regularly scheduled meeting of the Commissioners of Bridgeville was held on March 14, 2022, at 7:00 PM, at the Bridgeville Public Library. The following were present:

#### CALL TO ORDER:

The meeting was called to order by Commission President Carey.

#### **NEW COMMISSIONER OATH OF OFFICE:**

Solicitor Schrader swore in Marlene Saunders, Tom Moran & Bruce Smith as Town Commissioners. Their two-year terms will end in March 2024.

## **QUORUM PRESENT:**

President Carey reported that a quorum was present to conduct Town business.

#### **APPROVAL OF AGENDA:**

A motion was made by Commissioner Smith and seconded by Commissioner Moran to approve the agenda. Motion carried: 5 Yes votes, 0 No votes.

## APPOINTMENT OF COMMISSIONER OFFICERS AND STAFF:

A motion was made by Commissioner Smith and seconded by Commissioner Moran to appoint Dennis Schrader as Town Solicitor, to Appoint Davis, Bowen, and Friedel as the Town Engineer, to Appoint Sussex County Department of Assessments as the Town Assessor, Marlene Saunders as Commission Secretary, Bruce Smith as Commission President Pro Tempore and Tom Carey as Commission President. Motion carried: 5 Yes votes, 0 No votes.

#### APPROVAL OF MINUTES:

A motion was made by Commissioner Smith and seconded by Commissioner Saunders to approve the minutes from the February 14<sup>th</sup> Commission Meeting, and the February 28<sup>th</sup> Commission Workshop. Motion carried: 5 Yes votes, 0 No Votes.

#### **CORRESPONDENCE:**

Town Manager DeBussy stated that the Town received a thank you note from a couple in Heritage Shores about their mailbox getting fixed after it was accidentally hit while the Town plowed during one of the snowstorms.

Town Manager DeBussy stated that the Town received a letter from Sussex County officially awarding the Town with a grant in the amount of up to \$253,141. Town Manager DeBussy stated that the first \$100,000 does not have to be matched but anything above the \$100,000 does have to be matched dollar for dollar. Town Manager DeBussy stated that the requirements for it are similar to the ARPA funding and subject to approval by Sussex County. President Carey stated that this item will be on the agenda for the March 28th Workshop Meeting.

## **FINANCIALS STATEMENTS:**

Town Manager DeBussy read the following information from the February Financial reports:

#### Balance Sheet-

- General Fund-\$ 3,028,869.
- All Accounts \$ 6,119,704 (decrease of \$74,676 from January)
- Accounts Receivable \$49,117 (All Accounts include ARPA Fund Balance, Monies held for H.S. Special Taxes, & Bond Bill Funding.)
- Budget Report Target -66% (8 months into the budget year)
- Income \$ 1,808,479 (Income at 85.2% of the budget)
- Expenses \$1,285,157 (Expenses 64.5% of the budget) Net Income - \$570,092

## Accounts Payable-

The Town paid bills totaling \$ 52,257 during February.

Town Department reports were reviewed and discussed by the Commissioners and Town Manager DeBussy.

President Carey stated that Chief Parker had his 20th anniversary with the Town.
