

# March 2022 Town Manager's Report

### **Economic Outlook**

In March, the Town issued fourteen (14) building permits totaling \$23,575.37. There were six (6) building permits issued for new construction.

The Town received a check from the Recorder of Deeds in the amount of \$51,782.89 for realty transfer taxes (RTT) collected on our behalf during February 2022.

We have a balance of \$1,598,507.26 that may be earmarked for future debt payments or capital projects.

There previously scheduled Sheriff's sale for March has been pushed to April with updated amounts owed to the Town shown below:

- PODS GED S Main Dist, LLC- New Minor Development Plan Concept/Sketch approved by P&Z in September next stage is Preliminary/Final Submission. Expected Spring 2022.
- Rt 13 Self Storage of Bridgeville (13.41 Acre Parcel) Dove Estates, LLC Expected May/June

We have seen an exciting and steady increase in calls and meeting requests regarding potential applications on commercial properties throughout the Town. They will not appear in the report until either concept or preliminary applications are received.



# **<u>Code Enforcement Update</u>**

In March, we began a town-wide sweep of Code Enforcement. We could not enforce fines for code-related issues during the pandemic, so we are dealing with a multi-year backlog of items to try to catch up on. While it is not an all-inclusive list, many items include tall grass and overgrowth, sidewalk repairs, house repairs, fence repairs, visibility of addresses on the property, vehicles, driveways, and trash and debris on properties. Code enforcement officers will attempt to contact residents in person and by door hangers initially to resolve the problems and will then follow up with certified letters and fines if necessary.

### Municipal Park Planning Committee

Our engineers, Davis Bowen and Friedel, created a preliminary concept plan for the future Municipal park next to Town Hall. We encountered several challenges with redesigning the multiple entrances to the property and resolving some known parking lot problems. Still, we could finally bring the Park Planning Committee back together. At the kickoff meeting on Friday, April 8, we had Rita Hovermale (Resident, UUMC), Latoya Harris (Resident, Cornerstone Community Center), and Suzanne Janes (Resident, Heritage Shores). We walked the site, discussed the concept plan, and started strategizing for grant applications and community outreach. It is our goal to create a statement of purpose and information pamphlet, as well as establish a dedicated web page within the Town website for information, updates, and donations, bring the Memorial Brick's program back to life, and begin going after some potential funding opportunities to make this project happen!

# **Redistricting Committee Update**

The Redistricting Committee held its first meeting on Tuesday, April 5. This meeting was an introductory kickoff meeting for the work to be done with the redistricting process. John Laznik from the University of Delaware explained the data he has compiled from the 2020 census. The next meeting will be in the last week of April, during which the committee should have preliminary draft maps to begin working on.

#### **Employee Evaluations and Budget Preparations**

While spring is in the air and everyone is heading outside – we at Town Hall are hitting the books. In March, we completed staff evaluations. We are now gathering information to prepare for closing the budget for this fiscal year, get grant applications in by May, and start preparing the FY23 budget for May workshops.
