

### October 2022 Town Manager's Report

#### **Economic Outlook**

In September, the Town issued thirteen (13) building permits totaling \$24,140.75. There were five (5) building permits issued for new construction.

The Town received a check from the Recorder of Deeds in the amount of \$87,347.17 for realty transfer taxes (RTT) collected on our behalf during September 2022.

We have a balance of \$2,180,685.59 that may be earmarked for future debt payments or capital projects.

We have one Sheriff's Sale scheduled for November – 108 Delaware Ave.

We had no sales occur in the month of October.

### Jimmy's Grille/Blue Hen Restaurant Update

We are seeing a lot of buzz about the old Jimmy's Grille/Blue Hen Crossroads property - so we'd like to help put some of the rumors to rest.

Previous applications for a mini storage and other proposed changes to the property were denied by the Commission.

Our code allows for a restaurant to reopen without going through the Planning and Zoning and Commission review process because it is not a deviation from the existing use of the property. So any discussions of something OTHER than a restaurant are not valid - there have been no applications received or processed.

We were informed by the property owner that they have agreed to rent the restaurant to a tenant that does intend to open a restaurant, and they will be doing extensive work on the property over the next several months.

However, until we receive an application, we cannot confirm a name or type of restaurant. We do know that it will not be a large chain - this is a smaller, independent operation. We are thrilled to see activity and progress on a property that has been vacant for a few years now, and we hope the community is also eager to see and support new business ventures!

#### **Healthy Communities Delaware Grant**

By now, you may have heard that we have collaborated with Cornerstone Community Center on a project to obtain valuable community input for our next Comprehensive Plan Update in 2023. Soon, surveys will be available on our website, distributed by mail, and available during community events. Some of our residents may have already participated during Apple Scrapple, or during some of the events that have been hosted by Cornerstone Community Center. In the Spring, volunteers will also be going door to door to obtain input. This is an amazing opportunity to unite our community, and this is an extensive effort that is usually only seen in larger cities, like Wilmington, due to funding and staffing limitations.

We hope all of our residents are eager and willing to help shape the future goals and pathways of our Town.
