    - Jenn noticing uptick in complaints/concerns about school buses
    - Kevin Long Woodbridge Early Childhood Education Center located along US 13 in Greenwood has some safety concerns:
      - trying to manage a.m. and p.m. dropoff/pickup traffic needing to exit campus onto US 13
      - 2<sup>nd</sup> grade playground directly adjacent to US 13, only separated with a chain link fence
      - Not currently a speed reduction school zone on US 13
  - Relevant citizen concerns that came up at Greenwood local election
    - Delivery trucks
      - Existing issue: large delivery trucks on Governors Ave
      - New bakery coming to S. 1<sup>st</sup> St, which is smaller than Governors Ave- residents concerned about routing of trucks on this street
    - Impact of bus electrification on bringing transit to Greenwood
  - Upcoming DART public hearings about proposed service changes
    - o Georgetown: February 14, 1-3pm
    - Dover: February 16, 4-6pm
      - This hearing will have info about Sussex
  - Transportation YOU program
