Action Items

- WRA will schedule next stakeholder meeting. Invite sent for April 27, 2023 @1pm
- WRA coordinate plans for second public workshop, scheduled for the evening of Thursday, May 18.
 - Two sessions will be held: 1) Greenwood Library, 4-5pm; and 2) Bridgeville Library, 6-7pm.

Meeting Summary

- Project timeline:
 - Have moved into the phase of drafting plan
 - Stakeholder committee meeting in April to review draft recommendations/strategies
 - Public workshop in May
 - Wrap up the plan in June and move into monitoring/implementation phase

- II. Summary of public survey and workshop results
 - About 35 workshop participants and 47 survey respondents.
 - Survey offers additional insight on public perspectives; keep in mind it's not a scientific survey
 - o 35 of survey respondents were from Bridgeville, 7 from Greenwood
 - Highest priorities among those participating:
 - Safety (including addressing freight and navigation of other large vehicles)
 - Transportation capacity
 - o Preservation of rural character
 - Multimodal (bicycling, walking, etc.) accessibility and safety
 - Issues that seem to have a wider range of viewpoints, less clear consensus:
 - Agricultural industry corridors, local agricultural activity
 - Routing traffic through towns versus around
 - Capacity, traffic flow, and strategies to address those issues (e.g. widening, bypass, etc.)
- III. Group reviewed the draft community vision suggested edits based on survey and other feedback.
 - Group agreed with edits as follows:
 - o add safety and list it as first guiding principle of community vision
 - o adjust "agribusiness" term to more clearly reflect local agriculture
 - Greer suggested that Newton Road is more like an agribusiness corridor currently; companies there are large-scale, quite a bit of industrial type activity
 - New greenhouse proposal around Adam and Newton Roads
 - Been through PLUS process
 - Larger than local family-owned but not "agribusiness"; different from entities like Perdue and Montair
 - Will be shipping product in trucks out of state
 - Greer indicated people are feeling that Newton Road is becoming a truck corridor; asked about potential for bypass south of Bridgeville
 - Heath—Newton Rd bypass was built in part for beach traffic
 - Jenn—bypass is one various solutions that could be appropriate to address the kinds of issues associated with SR 404
 - Group briefly discussed Scope School at Newton Rd/US 13
 - Heath—the school district leases the space from O A Newton- for about 50 kids; do not have money to build a new building
 - Jenn—has asked attorneys about giving properties to schools
 - Greer mentioned concern about those living outside of towns (in the areas of Sussex County located around Greenwood and Bridgeville) not having representation in county land use decision-making; also traffic-intensive land uses tend to get pushed into these unincorporated areas
- IV. Full range of input from survey/workshop on the challenges and opportunities was presented (see details in the powerpoint). Key takeaways from the input:
 - Priority issues to focus on addressing as we draft the plan:
 - o Farm, school vehicles
 - Utility and construction vehicles
 - Freight vehicles, navigation
 - Agricultural economy / industry corridors
 - Balancing growth, in town versus along US 13 / outside of town
 - Capacity, traffic flow
 - Routing around vesus through towns
 - Connectivity
 - Key locations:

- US 13 at SR 16
- o SR 404 at Scotts Story Road
- Newton Road
- o Redden Road
- A number of issues identified through this process already have action/coordination underway (e.g., DelDOT is addressing issues on US 13 at Woodbridge Early Childhood Education Center in Bridgeville
- Next stakeholder meeting will involve reviewing the list of issues and drafted strategies associated with them.
- Some issues are of the type that will involve ongoing monitoring
- Jenn noted importance of two towns supporting each other and coordinating to direct growth
- V. Public workshop 2:
 - Christy suggested advertising through public libraries
 - Consider holding at libraries or Amity café (Greenwood) rather than high school
 - Group decided to aim for holding event May 18th at the town libraries
 - Aiming for in-person, presentation/Q&A format, at the library in each town (back-to-back), the evening of Thursday, May 18. Both libraries have family activities that evening and we hope to be able to attract some broader awareness/participation.
- VI. Miscellaneous discussion
 - Greer—do agribusinesses on Newton Road use town sewer and water?
 - Bethany—No. Proposed greenhouse and Mountaire are not located in the town
 - Greer's county council district has no representation on county planning and zoning committee
 - Lost representative when redistricting occurred--Georgetown gained a seat and this district lost theirs
 - Would prefer traffic to be directed to 404 and Cannon Rd
 - Jenn—a bypass idea such as this will require years of planning and design; coming out of this process a next step could be to conduct further study
 - Since pandemic, many people moving into area and working in DC/remotely
 - Christy—at their produce stand on SR 404, there is traffic all week/all year, see younger families come in Thursday and Friday, retired people on Mon-Wed
- VII. Next stakeholder meeting—mid to late April, 1pm timeslot
