### Action Items

- Stakeholder Committee—attend May 18<sup>th</sup> public information session, help promote information session, and contribute input on priority level of recommended strategies
  - attached flyer for May 18 public information sessions:  
1) Greenwood Library, 4-5pm; and 2) Bridgeville Library, 6-7pm.
- WRA—confirm library has posted the public information session flyer.

### Meeting Summary

- Discussion of draft plan strategies and priority level**--Andrea and Jenn presented slides summarizing draft strategies (corresponds with the spreadsheet, which was circulated 4/25 to stakeholder committee) and sought questions and group feedback on priorities.

- Summary of discussion points (see attached spreadsheet for additional details):
  - US 13 / SR 16 intersection: traffic signal infrastructure have identified for being brought up to standards, pedestrian infrastructure enhancements (e.g., crosswalk, curb ramps, etc.), and general crash cluster/safety issues
    - Chief Thomas—indicated the main concern is tractor trailers trying to make left turns, which cause other cars to have to back up and resulting in crashes.
    - Janet—do not see as much foot traffic demand in this intersection; some between the Bay to Beach Builders locations (southbound)
  - US 13/ at Governors Road and Roack Road: school related traffic entering/exiting US 13
    - Chief Thomas--was contacted by school and continue to try to have officer on Rock Road and Sussex Highway durign PU/DO- but an officer is not always available
    - School working with DeIDOT Traffic to have a study to get a light that can be activated when needed; timing might not be until after end of this school year
    - Kevin Long--school board approved new playground farther away from highway; hope to have completed before start of next school year
  - Passwater Farm Road at US 13: keeping access to incoming development from direct ingress/egress onto SR 404 and intersection area of US 13.
    - Corridor Capacity Preservation Program identifies US 13 as a route under this program, which focuses on coordination with Land Use agencies to plan for safe access management and capacity.
  - SR 404 / SR 36 (Scotts Store Road): variety of safety and operations concerns here, including intersection turn lanes configuration, no shoulders, and more broadly increasing traffic experienced and anticipated based on widening of MD 404.
    - DeIDOT having some higher level planning conversations around the SR 404 (DE) corridor and for nearer term would consider a study to evaluate and identify how to improve intersection configuration for safety and operation.
  - Pedestrian crossings of SR 36 (Market Street) in Greenwood: busy location with the Café and a few other adjacent businesses.
    - Contact between DeIDOT Pedestrian Coordinator and Town was initiated. Accommodating crossings in this area would be considered mid-block crossing, which has challenges. A pedestrian study would be needed to proceed with ped crossing treatments.
    - Jenn shared visual of artistic crosswalks in Milton that were created with involvement of local community. This might be an option for Market Street—though the artistic crosswalks are not standard; looking into what additional approval steps needed.
  - SR 16 / SR 36 three-way intersection: stakeholders reported this as an intersection where many vehicles are not stopping.
    - This could be a CTP candidate
  - Various curves identified in Roadway Sufficiency Assessment of the Coastal Corridors Study; will consolidate those all into a single row/entry in the recommended strategies spreadsheet for simplicity

II. **General comments associated with regional traffic—**

- Greer – more out-of-state travelers cutting through the towns and often speeding; traffic backing up around US 13 and Newton Road, particularly eastern side of intersection (near her house); feels desirable solution for issue is to keep through-traffic on SR 404 and off local roads (e.g., route eastbound traffic from Newton Road south on US 13 and east on Redden Rd.)
- Newton Road a freight-oriented corridor, increasingly so with developments such as hydroponic facility, and non-freight traffic need other options.
