The meeting was called to order by Commission President Carey.

QUORUM PRESENT:

President Carey reported that a quorum was present to conduct Town business.

AMENDMENT TO AGENDA:

On behalf of the town, he thanks all of the local organizations that are working tirelessly to help those affected. Commissioners received an invitation to the Heritage Shores Military Club Memorial Day Concert.

Town Department reports were reviewed and discussed by the Commissioners and Town Manager DeBussy. Town Manager DeBussy announced that Sussex County will be starting major work on the sewer mains; residents affected will be notified by those contractors. An update was provided in the report for the current Rental License Applications and Inspection numbers.

The new president of the Historical Society, Eric Calloway, introduced himself to the Commission, and talked about the "new life" he looks forward to bringing to the museum.

NEW BUSINESS:

Public Hearing-510 N. Cannon Street

President Carey opened a public hearing at 7:24 pm regarding the dangerous building at 510 N. Cannon Street. There was no public

comment; the hearing closed at 7:25 pm. The property has been deemed a dangerous property by the committee. The Commission agreed that the building is a danger to the surrounding area and the notice should be posted with a 5-day notice (Friday, April 14th). A motion was made by Commissioner Moran to file the resolution, seconded by Commissioner Tomeski. Motion carried. 5 Yes votes, 0 No votes.

Planning and Zoning Appointments

A motion was made to appoint the three applicants to Planning and Zoning by Commissioner Oliver; 2nd- Commissioner Saunders; motion carried. 5 Yes votes, 0 No votes.

Use of Town Property for Fundraiser

Town Manager DeBussy announced that a benefit concert was in the works to help raise funds for those affected by the tornado. The funds raised would be handled through a committee the Lions Club has for disaster relief.

A motion was made to allow the benefit to take place on Town property by Commissioner Tomeski; 2nd- Commissioner Moran; motion carried. 5 Yes votes, 0 No votes.

Grant-In-Aid/Donations

Cornerstone Community Center has been added to the Grant-In-Aid list. Commissioner Tomeski would like to donate \$200, Commissioner Saunders \$350, and Commissioner Carey \$200.

A motion was made by Commissioner to donate funds to Cornerstone Community Center, seconded by Commissioner Tomeski; motion carried. 5 Yes votes, 0 No votes.

Misc.

No miscellaneous items were discussed.

Commissioner Saunders thanked the volunteers for their response to the areas damaged by the tornado.
