Board of Adjustments

Proposed Changes to Town Code

Town Manager DeBussy requested a review of the code regarding mini-storage units. The Commission requested that the attorney draft a revision/clarification for the language in the code regarding mini-storage.

Commissioner Saunders requested a review of the code regarding the Land Use section; currently the language does not match the rest of the code. The Commission requested the attorney draft revisions to make it more cohesive.

Commissioner Oliver requested a review on the Overlay Zones. Town Manager DeBussy stated the change would not only change the code; it would change the Comprehensive Plan. The Comprehensive Plan is set for a five year review this year. The discussion of growth led to a discussion of hiring part time employees for each department.
