OPEN DISCUSSION

FY24 Operating Budget

Town Manager DeBussy provided documentation for the previously discussed budget and a resolution for the approved budget. A motion was made to approve the discussed Operating Budget by Resolution by Commissioner Saunders, seconded by Commissioner Moran. Motion Carried. 4 Yes votes, 0 No votes.

OPEN DISCUSSION

ARPA Allocations

Town Manager DeBussy suggested ARPA funding be used as matching funds to complete the Town's water facility plant.

A motion was made to use \$30,000.00 from ARPA funds as matching funds by Commissioner Oliver, seconded by Commissioner Moran. Motion Carried. 4 Yes votes, 0 No votes.
