



**ORDINANCE 2023-03**

**AN ORDINANCE TO AMEND CHAPTER 128, SECTION 128-1 OF THE  
CODE OF THE TOWN OF BRIDGEVILLE  
RELATING TO FEES:**

**NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE  
COMMISSIONERS OF BRIDGEVILLE AS FOLLOWS:**

**Section 128-1. Fees Established.**

Amend the Town of Bridgeville General Charges and Fees, by deleting the amount of \$500.00 for Single Meter Pit and \$625.00 for Dual Meter Pit and change it to the cost incurred by the Town of Bridgeville plus 10% and also add the cost of a Water Meter to cost incurred by Town of Bridgeville plus 10%.

Effective Date: This Ordinance shall become effective upon its adoption by a majority vote of the members elected to the Commission.
