

November and December 2023 Town Manager's Report

Economic Outlook

In November, the Town issued (7) building permits totaling \$728.45. There were no building permits issued for new construction.

In December, the Town issued ten (10) building permits totaling \$20,411.68. There were five (5) building permits issued for new construction.

The Town received a check from the Recorder of Deeds in the amount of \$35,679.93 for realty transfer taxes (RTT) collected on our behalf during October 2023 and \$55,528.97 for realty transfer taxes (RTT) collected on our behalf during November 2023.

We have a balance of \$3,001,013.36 that may be earmarked for future debt payments or capital projects.

There is currently one property scheduled for Sheriff's Sale in January 2024.

Board of Adjustment Hearings

On December 12, 2023, a Board of Adjustment hearing was held for two properties.

- 41 Harlequin Loop, submitted by Deanne Nacrelli a request for a variance from permitted projections into the rear lot setback of 15' from 'not permitted' to 5'11" and reducing the required rear yard setback from 15' to 9'1" in the Heritage Shores RPC to build an enclosed patio at Tax Map #131-14.00-334.00.
- Parcel 6, Adams Road, submitted by Donald Cornish a request variance from the minimum required lot area per dwelling of 9,000 square feet to



6,450 square feet in R-1 Single-Family Residential to build a single-family home at Tax Map #131-10.07-6.00.

The Board approved both variance applications.

Absentee Ballots: Available by February 16, 2024 Deadline for Voter Registration: February 20, 2024

The Bridgeville Municipal Election will be at the Bridgeville Public Library, 600 S. Cannon Street, between

the hours of 12:00 PM and 7:00 PM. The Bridgeville Commissioners have established five Election Voting Districts for Municipal Elections. This year, Districts 2, 3, and 5 residents will each vote for a candidate from their district to represent them on the Commission. All districts are for full two-year terms. Please note that the Town underwent Redistricting in 2022, and the districts were changed. If you are uncertain of your district, a voting district map is available for review at Bridgeville Town Hall and online at Bridgeville.delaware.gov.

The Town is currently soliciting candidates in Districts 2, 3, and 5 for the 2024 Municipal Election. The following qualifications apply to all candidates: (1) U.S. Citizen at least 21 years of age on or before the Election date; (2) Bridgeville Resident and Registered Voter in the State of Delaware for at least one year immediately preceding the Election date; (3) Registered Voter in the State of Delaware; (4) Lives within the Election Voting District they wish to represent; (5) Not convicted of a Felony. Prospective candidates must file a written



letter of intent with the Commission President or Secretary, along with other filing requirements, by 4:00 PM on February 2, 2024. Questions may be directed to the Bridgeville Town Hall at (302) 337-7135 or townofbridgeville@gmail.com.

All required flyers, forms, and additional information can also be found at Bridgeville.delaware.gov under "Info" and "Elections." Every U.S. citizen at least eighteen years of age and who has resided in Bridgeville for at least thirty days shall have one vote in their voting district during the election, provided they have registered in the State of Delaware. No person registered after February 20, 2024, shall be allowed to vote in the 2024 Municipal Election.

Radar Speed Sign – Market Street

The radar/speed sign on Market Street ceased functioning in December. This sign was originally funded by Senator Pettyjohn and (then) Representative Dave Wilson in FY14. Representative Jesse Vanderwende has approved funding for the replacement of this sign in 2024. The funding request was approved on January 4, 2024, for an estimated cost of



\$4,100.00. We sincerely thank Representative Vanderwende for his continued support of Bridgeville.

DWSRF Application Approval – Small Diameter Waterline Replacements

We have received approval for funding for an approximately \$2 million dollar waterline project. This project is expected to be funded in FY25 (est. March) after initial requirements are fulfilled at the request of the State. The funding is for interest-only payments with loan forgiveness after project completion.

In the application, we identified from our Asset Management Plan that the waterlines located at John Street, S. Laws Street, Oak Street, and around the Phillis Wheatley Elementary School are the oldest in Town. Due to the small diameter, they are not sufficient to provide the necessary fire flow and pressure during an emergency, which could have catastrophic impacts on the school, apartments, and closely placed housing near these lines. Recent hydrant flow testing in 2022 confirmed this data. The project is intended to replace these lines. We have been seeking this funding for over two years, so this is an exciting and enormous opportunity for our water system and residents.

Storms and Flooding

As a reminder – when we receive heavy, persistent rain, there is a chance for flooding throughout Sussex County. Areas in the FEMA-designated flood zone are highly susceptible to flooding. For Bridgeville, this is defined as the area surrounding the Bridgeville Branch, which includes nearby roadways. We continue to spread this message – to NEVER drive through water that is on roadways. You never know if the road has been washed out or other dangers



are lurking in the water – even the possibility of downed electric wires. We recommend signing up for emergency alerts from DEMA through the Delaware Emergency Notification System (DENS) using Smart911. These alerts can avoid catastrophes and help save lives. Anyone can sign up to receive these alerts via text and/or email at dema.delaware.gov.

Updated Fees at Town Hall

After a comprehensive study of neighboring Towns and Libraries, we have updated some of the fees for services offered at Town Hall. This information was sent out in the January 2024 newsletter and is posted on our website and also directly on the payment window at Town Hall.

The Fee Schedule for all fees at Town Hall is as follows:



Notary Services - \$5.00 (per stamp)

Fax - \$2.00 for up to 10 pages. To receive is per standard copy price. Fee includes transmission report copy. Cover page required.

Standard Copies - \$.25 per page

11"x17" to 12"x18" - \$1.00 per page

Scans - Standard size (8.5"x 11" and under) and emailed only, \$1.00 for up to 25 pages, (25-page increments) *Not for high resolution scans.

*We can also now provide higher resolution large format digital scans up to 24"x 36"- Scans will be emailed to you. We cannot print in large format. \$2.00 per page.

PLEASE CALL AHEAD for availability for notary or scanning services.

Street Acceptance Request

We have received a formal request from the developer at Heritage Shores for final inspection for Street Acceptance for Phases 3A and part of 3B – to include Champions Drive, Legends Way, and Greenfair Way. Town Engineers, staff, and Developers will comb through the infrastructure in this area to identify any lingering issues and move towards official street acceptance, which will come to a future meeting when ready.
