

INVITATION TO BIDDERS

Sealed Bids, in duplication, will be received by the **Town of Bridgeville**, until **3:00 p.m.** local time on **April 1, 2024** for the general construction of the **North Cannon Street Drainage Improvements and Miscellaneous Alley Repaving Project**, at which time the bids will be opened publicly.

Work includes furnishing all equipment material, and labor for the work as described in the contract documents which includes but not limited to approximately 4,600 square yards of asphalt mill & overlay, 430 lineal feet of 12-inch Class IV RCP, and two (2) storm inlets.

Bidders are required to provide bid security in the amount of ten percent (10%) of the bid sum. The successful bidder will be required to post Performance and Payment Bonds equal to one hundred percent (100%) of the contract price upon execution of the contract.
