QUORUM PRESENT:

Chairman Whaley reported that a quorum was present.

APPROVAL OF MINUTES:

NEW BUSINESS:

Lands of Wheatley Farms Inc- Lot Subdivision

Heritage Shores RPC Subdivision Plats Phase 6 and Phase 7

Representatives explained the application to subdivide plats for phases 6 and 7. Commissioners asked questions regarding the well house in phase 6; Town Manager DeBussy states the issues have been resolved and will be included in the future application for the lot subdivision.

Motion to recommend the Commissioners approve the subdivision. Motion Correia; 2nd – Correll; motion carried (7-0).

NEW BUSINESS:

PTV 1309, LLC dba Dollar General Market- Minor Development Plan Application, Final Submission including Billboard Lot Subdivision

Stephani suggested the Billboard Subdivision be submitted on a different application and reviewed by Wallace Montgomery. Commissioners reviewed the Minor Development Plan.

Motion to defer the Billboard Lot Subdivision until further review. Motion Correia; 2nd – Willey; motion carried (7-0).

Motion to approve the final site plan. Motion Correia; 2nd – Mervine; motion carried (7-0).
