Notice of Public Hearing was posted in accordance with the Town Charter. Public Hearing was open at 7:12pm. Representatives presented the final plan to commissioners. Commissioners questioned pedestrian access to the commercial

property (Food Lion) in front of the development, developers have tried to connect with the property owners with no success. They agree that a path would be beneficial, but they cannot force other owners to connect to anything they create. It was suggested to reach out to Linkside as another option. Commissioner Oliver requested a temporary easement be created for construction of the new water tower. Developers agreed to have that available for the Town to sign, and look forward to working with staff for any construction and maintenance needs. Public Hearing Closed at 7:41pm.

A motion was made to approve the Final Development Plan by Commissioner Oliver subject to correcting the outstanding issues; seconded by Commissioner Moran. Motion carried: 4 Yes votes, 1 No votes- Harris.
