The meeting was called to order by President Pro Tempore Harris.

**APPROVAL OF AGENDA:**

A motion was made by Commissioner Bravo and seconded by Commissioner Dutton to approve the agenda. Motion carried: 3 Yes votes, 0 No votes.

A motion was made by Commissioner Dutton to approve the minutes from November 10th and November 24th, seconded by Commissioner Bravo. Motion carried: 3 Yes votes, 0 No votes.

Commissioner Harris read Ordinance 2025-06 to amend Chapter 222 of the code of the Town of Bridgeville as it relates to designated streets.

**Hometown Heroes Banners Request**

Karen Johnson-Kemp, Bridgeville Public Library Director, requested approval for a new batch of Hometown Heroes Banners. Town Manager DeBussy stated there are poles available to expand the program.

A motion was made to approve a batch of 25 banners by Commissioner Bravo, seconded by Commissioner Dutton. Motion carried: 3 Yes votes, 0 No votes.

**2026 Municipal Election Calendar**

Town Manager DeBussy provided the final draft of the 2026 Election Calendar for approval.

A motion was made to approve the calendar as written by Commissioner Bravo, seconded by Commissioner Dutton. Motion carried: 3 Yes votes, 0 No votes.

**2026 Holidays Observed Calendar**

Town Manager DeBussy provided the final draft of the 2026 Holidays Observed Calendar for approval.

A motion was made to approve the calendar as written by Commissioner Dutton, seconded by Commissioner Bravo. Motion carried: 3 Yes votes, 0 No votes.

**Planning and Zoning Member Appointments**

Town Manager DeBussy provided a letter of interest for a Planning and Zoning Member. Commissioners decided to table the decision until the interested member satisfies their balance with the Town.

A motion was made to table the decision by Commissioner Dutton, seconded by Commissioner Bravo. Motion carried: 3 Yes votes, 0 No votes.

**Grant-In-Aid/Donations**

Commissioner Harris would like to donate \$250 to 4Troy Foundation-Woodbridge Warriors; Commissioner Bravo would like to donate \$100, and Commissioner Dutton would like to donate \$200. Commissioner Bravo would also like to donate \$200 to the Heritage Shores Military Club; Commissioner Dutton would like to donate \$150.

A motion was made to donate \$550 to the 4Troy Foundation-Woodbridge Warriors and \$350 to the Heritage Shores Military Club by Commissioner Harris and seconded by Commissioner Bravo. Motion carried: 3 Yes votes, 0 No votes.

**GOOD OF THE ORDER:**

Commissioners thanked staff for their work during the Tree Lighting Ceremony; they all enjoyed the event.

Commissioner Harris announced he would be volunteering as a judge for the Town of Greenwood's Christmas Parade, and a Greenwood Council Member would be a judge for our parade.
