

#1 Organization Meeting - January 14, 1963

Since no one filed to run for office for Town Commissioners, no election for this purpose was held.

Mr. James E. Culver called this meeting to order. Mr. Melson nominated Mr. Culver temp. Chairman, nomination seconded by Mr. Willey, nomination carried.

Mr. Culver nominated D. L. Melson as acting Secretary. Mr. Culver nominated by Mr. Melson for President of Board, seconded by Mr. Simons, Mr. Culver nominated Mr. Melson for president, nomination seconded. Mr. Culver elected by ballot - 4 votes to 1 vote.

Mr. Melson nominated for secretary, Mrs. Mildred Brown nominated for Treasurer, nominations moved closed. Secretary declared Mr. Melson and Mrs. Brown elected.

Mr. A. Dean Betts nominated for solicitor, nominations moved closed. Secretary declared Mr. Betts elected.

Mr. Wm. P. Short nominated for Towns Alderman, nomination moved closed, secretary declared Mr. Short elected.

President Culver made the following appointments

John K. Simons - Water & Sewer Commissioner
Earl C. Willey- Street
Daniel L. Short- Police

Regularly moved seconded and carried that the following amendments to the present Town Charter be presented to the State Legislature.

1. That State Motor Vehicle and State criminal codes be adopted.
2. In case of the death or resignation of a commissioner, the remaining commissioners be authorized to appoint a new commissioner to fill the unexpired term.
3. Clarify section 23 as to compensation of commissioners.
4. To amend, under section 23, that part dealing with the removal of town employees after five years service to read. " Any officer or employee may be removed by the Commissioners for sufficient cause; however, after five years service removal may not be made without a hearing before the full Board of Commissioners.

Regular meeting called to order by President James E. Culver.

Members present were Earl C. Willey, James E. Culver, Daniel L. Short, John K. Simons and Donald L. Melson.
