

REGULAR MEETING  
COMMISSIONERS OF BRIDGEVILLE  
JANUARY 9, 1967

Mr. Thomas J. Gray, Jr. and Mr. George F. Hardesty, Jr. each filed for two year terms. Mr. James E. Culver refiled for one year term. Since Donald Nelson and Daniel Short did not refile, there was no election in Bridgeville, Delaware. The hold over commissioners are Mr. Earl Willey and Mr. John K. Simons.

The meeting was called to order at 8:05 P.M. by President James E. Culver. Those present were as follows:

Mr. John K. Simons nominated Mr. Dean Betts as City Solicitor. Seconded by Mr. Earl Willey. No further nominations. Approved by Board.

Mr. James E. Culver nominated Mr. George H. Torbert, Sr. and Mr. Harry Helm for Alderman and Assistant Alderman, respectively. Seconded by Thomas J. Gray, Jr. No Further nominations. Approved by Board.

After some discussion, it was the decision of the Board not to hire a City Assessor.

Mr. Earl Willey made a motion to reappoint Frank Galante, Police Chief, Alexander Sharon, Police Sargent, and Lewis Frampton, Police Corporal for 1967. Motion seconded by Mr. John K. Simons and approved by Board.
