SPECIAL MEETING
COMMISSIONERS OF BRIDGEVILLE
FEBRUARY 1, 1966

Meeting called to order by President James E. Culver at 7:30 P. M. held in the office of Ralph and Paul Adams.

Commissioners present were: James E. Culver
Donald L. Nelson
John K. Simons
Daniel L. Short
Earl C. Willey

The President reminded the Board that no formal application had been made requesting a grant from the State of Delaware for the sewer project which includes the collection system and treatment plant. The town became eligible for a Grant under chapter 122, Vol. 55, Laws of Delaware, 1965.

Thereupon, after full discussion and upon motion duly made and seconded, the following resolutions were unanimously adopted:

1. BE IT RESOLVED by the Commissioners of Bridgeville that the President be and he is hereby authorized and directed to cause to be prepared an application for State Grant for a sewerage project relating to intercepting sewers completed in 1965 which is to be submitted to the State Board of Health pursuant to Chapter 122, Volume 55, Laws of Delaware;

AND BE IT FURTHER RESOLVED that the President of the Commissioners be and he is hereby authorized and directed to execute and deliver to the State Board of Health the application for sewerage project for intercepting sewers, together with such other documents as may be required by the aforesaid State Board of Health.

2. BE IT RESOLVED by the Commissioners of Bridgeville that the President be and he is hereby authorized and directed to cause to be prepared an application for State Grant for a sewage treatment plant now under construction which is to be submitted to the State Board of Health pursuant to Chapter 122, Volume 55, Laws of Delaware;

AND BE IT FURTHER RESOLVED that the President of the Commissioners be and he is hereby authorized and directed to execute and deliver to the State Board of Health the application for a sewage treatment plant, together with such other documents as may be required by the aforesaid State Board of Health.

Commissioners agreed that town should advertise in Sussex Guide, for applicants for Town Alderman, also Manager for new Sewer Disposal Plant.
