A request for an additional street light to be placed on Edgewood Street opposite 308 Edgewood Street. Request submitted by George Torbert, III and R. J. Bennet. The Board instructed Street Commissioner Earl Willey to investigate same and have one erected if he thinks it is necessary.

Police Commissioner T. J. Gray, Jr. Submitted plans and specifications for remodeling of rear portion of existing town hall to be used for three new jail cells, storage, etc. Mr. Gray made a motion to advertise for bids immediately to do above stated work. Seconded by Earl Willey and approved by Board.

Mr. Gray made a motion to pay time and material to Earth Movers to move existing pile of dirt by entrance way to Disposal Plant and grade and seed along south side of branch. Also to grade and reseed along roadway where soil has washed away. Seconded by Earl Willey and approved by Board.
