REGULAR MEETING
APRIL 14, 1969

Meeting called to order at 8:15 PM by President Paul A. Lynch.

Members present were Earl C. Willey, J. K. Simons, Wm. Reynolds and Earl C. Willey.

Minutes of two last meetings were read and approved.

Fines turned in by Alderman Frank Galante were \$915.50.

Motion made by J. K. Simons to accept Ordinances #522 and 523 prepared by Town's Attorney, Dean Betts. Seconded by T. J. Gray, Jr. Copies attached to these minutes.

Earl C. Willey made a motion to hire Franklin Fountain as a full time police for summer months. This was seconded by J. K. Simons.

Earl Willey made a motion to discharge Frank Galante as Town Alderman as of 12:00 PM on April 14, 1969. T. J. Gray, Jr. seconded this motion.

Earl Willey made a motion to hire Frank Galante as Chief of Police. Motion seconded by T. J. Gray, Jr.

Motion made by Earl C. Willey to hire George H. Torbert, Sr. as Town Alderman as of 12:10 AM as of April 14, 1969. Seconded by Wm. R. Reynolds.

There was a discussion about the police pension fund.

Reports were given by all department commissioners about their plans for the year.

Motion made by Earl C. Willey to invest \$20,000.00 in Bridgeville Building & Loan Association and \$20,000.00 in debantures with Baltimore Trust Company. This was seconded by J. K. Simons. Money was from the Waste Treatment Account.

DANCEHALLS

Sec. 523

(a) No person, firm or corporation shall operate, maintain or conduct a dancehall where dancing is permitted after 12:00 o'clock Midnight unless a permit to extend beyond 12:00 is first obtained from the Commissioners of Bridgeville.

(b) A permit may be issued extending the hour of any dance beyond 12:00 o'clock Midnight where such dance is being operated by any public authority, by a charitable organization, but in no event shall the time extend beyond 2:00 a.m.

(c) Whoever violates this Section shall be fined not less than \$50.00 nor more than \$100.00 or imprisoned for a period not to exceed 30 days.

PINBALL MACHINES; BILLIARDS;
POOL HALLS

Sec. 522

(a) No person, firm or corporation shall operate, maintain or conduct a billiard, pool, bagatelle or pigeonhole table open to the public or permit the playing of any pinball machines within the town limits of Bridgeville between the hours of ~~11:00~~ a.m. and 8:00 a.m. on Monday through ~~Friday~~ or during ~~Saturday~~ Sunday of any week.

(b) Minors under the age of 16 years shall not be permitted to participate, engage in or play billiards, pool, bagatelle or pigeonhole table or pinball machines or frequent, loiter, go or remain in any hall maintained, operated or conducted as a billiard, pool or pinball machine hall or any combination thereof.

(c) All gambling is prohibited in the maintenance, operation or conduct of a billiard, pool, bagatelle or pigeon-hole machines.

(d) Whoever violates this section shall be fined
