

Meeting No. 10 (Regular) held in Town office on May 9, 1955.

Meeting called to order at 8:30 PM by President James E. Culver. All members present.

Minutes of Meetings No. 8 and 9 were read and approved. Delegation from the Lions Club present consisting of James Scott, Edwin James, and Paul Horsey. They discussed incentives to be offered by the Town to try and bring new businesses to Bridgeville. Free taxes and water for a certain period of time were two suggestions offered by the visiting group. New sewage system and disposal until were also brought up for discussion by the delegation.

Town Alderman's report was read and approved. Arrests totaling 24 by D. M. Dimes, Jr. and 23 by Granville Wilkins were reported for the previous month. Total fines collected for the month of April were \$326.75 less seven costs of \$24.50 leaving a balance of \$302.25, which was turned over to Fairbanks for deposit to the Town account.

Motion made by L. W. Rowe that the Town accept the proposition as made by the State Highway Dept. concerning the installation of a blinker light at the intersection of Routes 18 and 404 on the West end of Market Street. Seconded by Daniel L. Short. Motion carried. Copy of Highway Dept's. letter on file in the Secretary's file.

Sewer outlet was checked by Fairbanks and he will be unable to handle the necessary repair work due to the fact that the drain pipes into the ditch are too heavy. He is to contact the crane operator, who is cleaning out the ditch through Town, on the possibility of using the crane for some of the repair work. The operator was also to be asked if the crane could be allowed to dig a section of the ditch deeper for the use of the Fire Company in pumping water at the two bridges along the ditch; one on North Market Street and the other on North Cannon Street.
