George H. Torbert II, Town Adlerman, presented \$615.00 for fines collected for the month of April.

J. Simons made a motion to lay-off Mr. Chaffinch, Custodian of the town dump, effective June 1, 1967. Seconded by E. Willey and approved by Board. Purpose of this is to make the dump available to the townspeople seven days a week as well as save some money.

T. J. Gray, Jr. Police Comm., reported to the Board that Police Officer Alexander Sharon worked the 12-midnight to 8 A. M. shift 5-7-67. Mr. Gray stated that it was reported to him Sunday morning by Chief Galante that the town police car was missing. After four hours it was found locked and parked in T. G. Adams & Sons yard. He stated that it was established that Officer Sharon left the police car parked in front of 407 Delaware Ave. at 4:00 A. M. and went off duty, and that he left on vacation at 7:15 A. M. on a trip to Mass. Mr. Gray stated that he recommends Officer Sharon be requested to meet in a special session with the Board immediately upon his return to answer the above charge of being off duty and out of town without knowledge of these facts to either Chief Galante or himself.
