Meeting called to order by President James E. Culver at 8:10 P.M.

to the town. T. J. Gray, Jr. made a motion that Mr. Chaffinch
be permitted to remain in the dump at no cost to the town provided
he does not request the dump patrons to deposit their trash in
several different places for his use only. Motion seconded by
E. Willey and approved by Board.
