

COMMISSIONERS OF BRIDGEVILLE
REGULAR MEETING
MAY 12, 1969

June

Meeting called to order by President, Paul A. Lynch
at 8 P. M.

Members present were Earl C. Willey, Wm. R. Reynolds,
T. J. Gray, Jr. and John K. Simons.

There was a discussion about the town dump and it was
decided it would be better to close it as of June 1st
and to notify the public by sending a card to each household.
Also to put a notice in the Paper.

John K. Simons said he had talked with Mr. Newton about
the water line he had asked the town to run to the new
Swift Plant that they are planning on building and he
told him it would to much expense for the town to undertake.

Mr. Willey said there were several roads that neede patching
in town as soon as money was available.

T. J. Gray, Jr. said that everything in the Police
Department seemed to be running smoothly and that the
new mattresses he had made were ready to pick up. These
will be used on the bunks at the jail.

Mr. Lynch talked about the mower at the sewer plant not
working very well and Mr. T. J. Gray, Jr. said he would
see if repairs would help it or if they would have to buy
a new one.

There was a discussion about the operating of the water
Department and Mr. Lynch felt that money was being lost
and he would like to appoint a committee to look into this.
It was suggested by him that Mr. R. W. Harris and Mr.
Leroy B. Truitt might assist in this. This was approved
by the floor.

The Board talked about the Sewer Meters of Cannons and
American Consumers, Industries, and who should be responsible
for the maintenance of these. It was decided to investigate
this further and continue the discussion at the next meeting.

Motion made by Earl C. Willey to pay bills as listed below.
Seconded by T. J. Gray, Jr. and approved by the floor.
