REGULAR MEETING
JULY 14, 1969

Meeting called to order by President, Paul A. Lynch at 8 P. M.

Members present were Earl C. Willey, J. K. Simons and Wm. R. Reynolds.

Mr. Robert Smith from the Water and Air Resources Commission was present to give his advice and recommendations about the operation of the Disposal Plant. No. 1 problem at this time seemed to be the odor that we sometimes get. He felt that things were doing fairly well there as far as maintenance of the plant. He gave some recommendations and said he would get together with Harry Hammond and see what they could do.

J. K. Simons said he had talked with Percy Sterling, who is one of the Engineers that designed the plant and that he would come to Bridgeville for a day and explain in detail how the plant should work.

Mr. Lynch thanked Mr. Smith for coming to our meeting.

J. K. Simons made a motion to pay all bills, seconded by Earl C. Willey.

Mr. Lynch asked J. K. Simons for a report from his department and he said that the pumps had been fixed and he also suggested that we have a couple more wells, so if we need them. There was a discussion concerning this and it was decided to wait a little longer.

Board agreed to move water parts from the jail yard to the disposal plant and store where they will have more protection.

Also Present were Mr John Moore from the Economic Development Department and Mr. John Stevens of the State Development Dept. That told the Town Commissioners of an industry that would like to locate in Bridgeville that would make rugs. Being near the Dupont plant would also be an asset to them. They would start with fifty employees and increase as needed up to two Hundred and Fifty. They had made application to the Office of Economic Development Department for aid and Mr. Moore seemed to think things looked in good order to him. There would be money that would have to be raised by the town or townspeople to get the business here, so Mr. Lynch told them he would call another meeting ~~within~~ two weeks and the business men of the town would be notified, so they could hear about what the business would need and see if they wanted to assist in getting it here.

Letters will be written to our attorney Dean Betts, asking him to get in touch with Walter Orendorf and Walton Owens about property they own that should be taken down or repaired.

Being no further business meeting adjourned.
