

Meeting No. 15 (Regular) held in Town Office on Monday, Aug. 8, 1955.

Meeting called to order at 8:00 P.M. by Pres. James Culver.

All members present.

Representatives from various service clubs and orginazations were present along with the Town Attorney, Daniel J. Layton, Jr. The other persons present were Paul Horsey, Lions Club; Ralph Davis, Legion; Louis Stanley, PTA of Phyllis Wheatley School; Ella Dime, Fire Co. Auxiliary; Alberta Smith, Fire Co. Auxiliary; Nellie Bennett, Professional Womens Club; Bill Stephens, Breakfast Club; Myer Dimes, Fire Co.; and F. J. Willey, Fire Co.

Mr. Layton gave a brief talk describing zoning and stating the effects a zoning ordinance would have on a Town such as Bridgeville. Mr. Layton's talk was followed by a question and answer period with the representatives asking questions on various items concerning the possible new zoning ordinance. All of the representatives were asked by Pres. Culver to report back to the Commissioners at the next meeting on Sept. 12 if their groups would be willing to back a zoning ordinance and to do a little work in bringing it into law.

Total of \$105.00 in fines collected for month of July from Mag. Wm. Short for arressts made by Granville Wilkins and D. M. Dimes, Jr. Alderman O. T. Warrington turned in \$328.25 for arrests made by both officers. Wilkins had 28 cases and Dimes 45. Mr. Warrington, according to the figures available to Fairbanks, came out \$29.50 short which he is to be asked to turn in after Fairbanks checks his report with him.

Minutes of meetings No. 13 and 14 read and approved.

Pres. Culver scheduled a special meeting on Aug. 15, 1955 to dicuss the applications for town officer and to hire a person to fill the vacancy created by Granville Wilkins resignation.
