The Commissioners of Bridgeville at a meeting at the Town Offices on August 16, 1956, it appearing from discussion that a certain petition by H. P. Cannon and Son, Inc. and Atlantic Ice Manufacturing Company for the closing of Acre Street in said Town having been filed and that consent to the closing of said Acre Street having been signed by Lenora White, Virginia Hope and W. A. Lucas, the three abutting owners on said street other than the aforementioned petitioners, hereby resolve as follows:

That Acre Street, an unimproved dirt road within the boundaries of the Town of Bridgeville, having been supplemented by a new and modern hard surface road leading from the Federalsburg Highway to the Wesley Church, be and the same is hereby closed and that the bed of said street where it abutts the respective properties of H. P. Cannon and Son, Inc., Atlantic Ice Manufacturing Company, Lenora White, Virginia Hope and W. A. Lucas and enclosed by said abutting owners to the extent that said street adjoins the lines of their respective properties; reserving, however, to the Town of Bridgeville the right to enter upon the bed of Acre Street at any and all times in the future and through any and all fences and gates that may hereafter be placed upon the bed of Acre Street for the purpose of maintaining, repairing and renewing the fire plug and water lines situated in or near the bed of said street.

The foregoing motion having been made and seconded it was unanimously carried by the vote of all of the Commissioners present.
