Mr. Lynch then read a letter from Percy Sterling concerning his visit to our Disposal Plant a few days ago. He felt that our Disposal Plant was kept clean and the boys were doing a good job. He stated the grease should be taken care of by Ralph & Paul Adams, Inc. as it was in the recommendations that they had given before the plant was built and that grease will damage the plant. He also stated that we will get no money from the government until the grease is taken care of.

It was decided by the Board that Ralph & Paul Adams, Inc. be given 60 days to clear the grease or be cut off from the town sewer. A letter of that effect will be sent to them.
