He said that Bridgeville would be eligible for \$5400.00 upon approval of application for Subgrant. Mr. Gray said he would call District Attorneys office to get a better understanding about the collection of Fines, as there was a discussion among the Board members, as wheather or not Town Alderman's collection of fines would be like the State Courts, where by people could pay later.

It was decided that, there be a Special Meeting on Monday night to plan how to use money for police.
