At the regular monthly meeting of the Commissioners of Bridgeville held in the Town Office October 14, 1963, the Commissioners commissioned four residents of the community as a Human Relations Commission. The Board has felt for some time that there was a definite need for this Commission to assist in handling any problems which might arise in the course of normal business within the town.

The following men were appointed: Mr. William Dix, Mr. George Dredden, Mr. Ralph Scott, Jr., and Rev. Edward R. Wilkins. This commission was created to work in conjunction with the Governor's Human Relations Commission, Otis Smith, chairman.

The following was adopted as the Bridgeville Commission's Credo. We, the members of the Bridgeville Human Relations Commission of the Town of Bridgeville do hereby wish to submit the following statement as our credo. We feel this is our first responsibility to help establish a general working ground for both ourselves and the Town.

We must help create and maintain congenial relationships among and between the races. The Commission's area of responsibility will rest in mediation and conciliation with any situation that may cause friction in the area of human relations. This will include both those that may be apparent now and any that may develop in the future.

We do not deem it our responsibility or purpose to act in a quasi legal nature or hold enforcement powers. We do feel that it is within the best interest of the citizens of the town to foster the best possible relationships, to maintain human dignity and rights of individuals and to foster growth and advancement of the total community in all aspects.
