

REGULAR MEETING  
COMMISSIONERS OF BRIDGEVILLE  
OCTOBER 9, 1967

Meeting called to order by President James E. Culver at 8:00 P. M.  
Other members present were T. J. Gray, Jr., Earl Willey  
and G. F. Hardesty, Jr.

Also present was Mr. Fisher of Blades, Dela. Police Chief and  
Vice-President of the Fraternal Order of Police for Sussex  
County and Mr. Smith, President of the Blades, Dela. Town  
Council and also an associate member of the Fraternal Order of  
Police, and Mr. Al Sharon.

The purpose of their presence was to listen to the reasons and  
remarks why the Bridgeville Town Commissioners asked Mr. Al  
Sharon to resign his position as a Bridgeville, Dela. Police  
Officer. Mr. Sharon believes his name and character has been  
hurt and has solicited the help of the Fraternal Order of Police.  
After discussion of about one hour and three quarters, the  
above mentioned persons left the meeting.

Fines collected for the month of September were \$1,000.00 and presented to the Commissioners by Alderman George Torbert, Sr.

Police Commissioner T. J. Gray, Jr. stated that the applications that he has received for the vacant police job have been studied and he recommends Mr. Virgil Kinder of R. F. D. #1., Bridgeville, Dela. After further discussion Earl Willey made a motion to hire Mr. Virgil Kinder for six months probation before he becomes a permanent officer of the Bridgeville Police Force. Motion seconded by Mr. Gray and approved by the floor.

President Culver presented two designs concerning an outside sign for the new town hall. These designs and prices were presented by William V. Sipple & Son of Milford, Dela. A design was selected and President Culver is to get the opinion of the architect before construction is started.

President Culver reported that the Bridgeville Building and Loan Association have advised they will be unable to issue more paid up shares due to the lack of loans at this time. The paid up shares have been purchased with money from the Sinking Fund, which is set up for the purchase of a water tank in the near future. Since local banks can legally pay only 4% on savings accounts, we have been in touch with the Wilmington Savings Fund Society of Dover, Delaware who pay 4 1/2 % on savings accounts. They have agreed to an account with the Town of Bridgeville. Upon motion duly seconded the following resolution was unanimously adopted:

RESOLVED that an account in the name of Commissioners of Bridgeville, be opened with the Wilmington Savings Fund Society, Dover, Dela. subject to the order of the following Officers: President and Secretary.
