

Meeting No. 21 (Regular) held in Town Office on Monday, November 14, 1955.

Meeting called to order at 8:10 PM by Pres. Culver with all members present.

Town Alderman's report read and approved. Mr. Warrington turned in a check for \$418.75 for fines collected during the month of October. Magistrate Short turned in \$110.00 for the same period. Total fines, which were turned over to Fairbanks, for the month of October were \$528.75.

Delegation from the area of Jacobs Drive and Elm Street, Law Street and John Street and Elliotts Drive were present requesting that the Town furnish water and sewer to Jacobs Drive, Elm Street and Elliotts Drive. The group consisted of the following persons: George Torbert, Nelson Cannon, Mr. and Mrs. A. E. James, Mrs. Ellis Myers, John K. Simons, Walter K. Hoch and R. Francis Adams. Louis Stanley and Walter Orendorf were also present.

Sam Shannahan of the Sam Shannahan Well Co. also present at the meeting and left diagrams of the new well in the corner of the school ground and also certificates for the State Board of Health concerning the well. Mr. Shannahan also gave his Company's estimate for installing a new sewer pipe under the railroad on Market Street. Final decision delayed until Fairbanks could check with the Railroad.

Mrs. Mary Frances Varney, Director of Civil Defense for Sussex County was also present in order to collect facts concerning the Town, such as our resources, facts about the water and sewer systems and other pertinent information. A Motion was made by Earl Willey that the Town pay for printing 700 Civic Survey cards for the use of the Civil Defense for a survey in and around the Town of Bridgeville to obtain information for use in case of an emergency. Seconded by Daniel Short and so carried.
