Mr. Culver reported in case of Town of Bridgeville versus Wm. Courtney Evans on chrage of drunken driving. Case in obeyance.

Mr. Culver read ordinance for third time relative to excessive noise.

1. It shall be unlawful for any person, firm or corporation to operate or cause to be operated any motor vehicle, whether passenger automobile or truck, upon the streets, byways or alleys of the Town of Bridgeville in such manner as to cause undue, excessive or annoying noise whether such noise shall be caused by the lack of or inefficiency of mufflers or other silencing equipment or by the high speed operation of the motor in such automobile or truck.
2. Any person convicted of a violation of Section One of this Act shall forfeit and pay in addition to the costs of the proceeding, a fine of not less than Ten Dollars for a first offense, and a fine of not less than Twenty-Five Dollars for a second or any subsequent offense.

3. The use of the word "person" in Section Two of this Act shall be construed to mean the president or any officer of any corporation and one or more of the members of any firm involved.

Upkeep of dump was discussed. Mr. Short moves we charge all outside business \$25.00 per year and outside residents \$5.00 per year for use of town dump. Mr. Culver is to call Mr. Layton concerning legality of charge and necessity of Ordinance.

Be it Ordained by the Commissioners of Bridgeville in regular monthly assembly that:

It shall be unlawful for any person, Firm or Corporation who are not Tax Payers of the Town of Bridgeville to enter upon The Town Dump located to the west of the Town of Bridgeville for the purpose of depositing therein any trash, garbage or refuse of any nature whatsoever, without first obtaining from the Commissioners of Bridgeville permission so to do.

Any person, firm or corporation convicted of a violation of this ordinance shall in addition to the costs of the proceeding, forfeit and pay a fine of not less than five Dollars (\$5.00) nor more than Twenty-Five Dollars (\$25.00)
