REGULAR MEETING
DECEMBER 9, 1968

Regular meeting of the Town Commissioners was held in the Town Hall, 8 P.M. on December 9, 1968.

Meeting was called to order by John Simons, President. Others present were Earl Willey, T. J. Gray, Jr. and Paul Lynch, acting secretary.

A motion was passed approving the minutes of the regular meeting held November 11, 1968 and the minutes of a Special meeting held November 19, 1968.

Fines turned in by Town Alderman, George H. Torbert were \$1463.00.

A motion was passed that the Town Commissioners reimburse in full, Leroy Tull, the amount he apid George Jones and Company for connecting his house to the rebuilt sewer lines in the rear of his property. It cost him \$557.47 for this work. He had previously been sent a check for one-half this amount. A check for the balance will be sent to him.
