Motion made by Earl C. Willey to pay all bills, seconded by Wm. R. Reynolds.

Mr. Lynch asked for report from each department. Earl Willey, Street Commissioner, reported all work done on the streets and they had just been cleaned. The parking problem was again brought up and the board felt that Mr. Lynch go to the School Board meeting about the parking out there.

Mr. T. J. Gray, Jr., Police Commissioner, reported his department seemed to be alright and that he would like to get a radio for the extra police car. He had received \$5400.00 from the Delaware Agency to fight crime and felt he could include the purchase of this in that money.

Mr. Lynch read a letter from the State Board of Health about Fluoridation of Public Water Supplies. He said he felt the sewer men could take care of this and to pay them a little more money for the extra work. As this would be an added cost to the town there would have to be something set up in the budget to take care of it.

There was also a discussion on garbage collection. Raymond Smack had said he would like a town pick-up at \$.35 a house. This will have to be paid by the homeowners to the town. Therefore it would be to vote on at a referendum at the regular town election held on January 5, 1970. It would be decided later how it would be billed.

Being no further business meeting adjourned at 9:30 P.M.
