


Meeting No. 23 (Special) held in Town Office on Monday,

Meeting called to order at 8:35 P.M. by pres. James Culver.


All members present.

Meeting No. 11 (Special) held in Town Office on Wednesday 5/25/55, at 3:30 P.M. All members present plus Town Attorney.

Mr. Malcolm L. Webb was also present at the meeting from the University of Pennsylvania concerning zoning for the Town.

Several questions were asked concerning the availability of water, sewers, lot sizes, and various other general information. Mr. Webb gave a brief description of the purpose of zoning and effects it has on a small community like Bridgeville. Policy committee was discussed. This would be appointed by the Town Council and would have the power to change a zoning ordinance as the need arises.

The Institute, that Mr. Webb represents, is to prepare a more detailed estimate of cost and the duties they would undertake and submit to the Town Council. Proposal will also state what the Zoning Commission could do to cut the original cost by completing various details of the zoning act.

Cost of the Institute's services would be billed monthly. It would also be possible to carry the cost over a longer period of time, possibly into the next budget period.
