Motion made and carried that town accept deed from Charles Anderson for Cannon Street extended and that town pay for surveying of same.


Motion made by Daniel Short that Alfred E. Holt's application for town police be accepted on a 30 day trial, beginning wage to be \$55.00 per week.

Meeting was called to order by President James Culver at 9 P. M.


Members present were Mr. John K. Simons, Mr. Daniel Short, Mr. Donald Melson and Mr. Culver.
